## **TERMS AND CONDITIONS:**

- 1] **Scope of work:-** The work is to be carried out as per instructions of MSETCL & concerned authority.
- 2] **Period of contract:-** The period of contract is till 31st March 2022 from date of LOA given.
- 3] **EMD Payment**: You have to pay an EMD amount of Rs.5000/- online while submission of Bid.
- 4] **Security deposit :-** Contractor will have to pay Security deposit in the office of Superintending Engineer, EHV Projects Circle, M.S.E.T.C.L., Kalwa, in the form of Cash/ Demand Draft / F.D.R. of any schedule bank drawn in your name and lien of "Superintending Engineer, EHV Projects Circle, M.S.E.T.C.L., Kalwa", duly discharged equal to 3 % of the value of the work order and submit the same to this office within seven days from the date of receipt of work order. No interest will be allowed on this deposit. If on breach of contract during contract period, S.D. will be forfeited without assigning any reason. The amount will be refunded after expiry of warranty period subject to deduction, if any, forfeited as per he terms and conditions.
- 5] Rates should be quoted showing ex-works and GST, separately in SRM.
- 6] If computer and printers are required to be repaired at your shop necessary transportation expenses shall be paid by you.
- 7] AMC works involves quarterly servicing of computers, laptop, printers and LAN and attending breakdown immediately on intimation for the purpose of servicing, cleaning, material required failing which penalty @ Rs.200 will be charged, Maximum response period will be of forty eight hours for each break down call.
- 8] The bill in duplicate should be submitted quarterly which shall be paid after certification and Service Entry by concerned Engineer-in-charge and thereafter audit and passing at concerned office i.e. SE, EHV Projects Circle, Kalwa within reasonable time.
- 9] The agreement is required to be executed by bidder with this office, on stamp paper of Rs. 500/containing all the above terms and conditions of the order before start of work. The cost of stamp paper should be borne by the bidder.
- 10] The tenderer must possess the following documents and they should essentially submit certified/ Attested scanned copies of the same, otherwise, the tenderer will be dis-qualified.
  - a) Valid Mumbai Shop Act Certificate/ Intimation Receipt.
  - b) GST registration certificate (if applicable). If not applicable, certificate from CA with UDIN number stating that GST registration is not applicable to you.
  - c) Copy of Company/Firm Pan Card.
  - d) Income Tax Returns for last three Assessment Years (2018-19, 2019-20 & 2020-21).
  - e) Udyog Aadhar Certificate (if exempted from EMD payment).MSME Certificate required.
  - f) Experience certificate for one similar nature of work done (at least 50% of the estimated value.) in any one of the last five financial years i.e 2016-17, 2017-18, 2018-19,2019-20 & 2020-21.

- 11] Income tax, or any other taxes as applicable will be recovered from your bills on the total value of the work done as per the prevailing rates.
- 12] Bidder should not submit "Conditional offer", such conditional offer shall be liable for rejection.
- 13] The offer shall be valid for acceptance period of 60 days from the date of submission of the offer. During this period, no bidder shall be allowed to withdraw its offer. Such withdrawal during the said period will result in forfeiting of EMD.
- 14] Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regard are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds.
- 15] If the bidder has any doubt regarding meaning of any portion of the enquiry conditions/ specifications, he should get clarified from the office of the undersigned.
- 16] Dispute: In case of any disputes, the decision of the undersigned shall be final and binding on the contractor.
- 17] The MSETCL's general/ Technical/ Commercial conditions for work contract are also applicable and will be binding on bidder. Right to reject any or all quotations without assigning any reason is reserved by the undersigned.
- 18] The manpower required for this job will have to be arranged by you.
- 19] All expenditure on material shall be borne by you.
- 20] Other standard terms and conditions of MSETCL for orders will be applicable in this case also.
- 21] In case of any dispute arising out of your contract, it will be in the jurisdiction of Thane only.
