**Technical bid (Qualifying Criteria):** Tenderer should upload the following digitally scan copies of original documents / certificates online under technical bid.

- 1) **Turnover:** The bidder should have turnover/completed work of unloading of transformer and accessories worth 50% of tender estimate or more of preceding three financial years. The bidder should have to produce certificate duly certified by Chartered Accountant in the proforma given in Annexure- VIII
- 2) **Work order copies and Exp. Certificate** for the **Work of** Annual contract of unloading of Power transformer being received within the jurisdiction of Major Store 'A' Wardha for the year 2021-22

During last 5 years ending last day of month previous to the one in which applications are invited should be either of the following:-

**Experience of having successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders** during last 5 years ending last day of month previous to the one in which applications are invited.

(Note: - **Experience certificate** of having done Work of unloading of power transformer of various capacity up to 200MVA /400MVASimilar work of unloading transformer office of Govt. / Semi Govt. / relevant establishment)

- 3) Current valid copy of **GST** Registration
- 4) Professional Tax Certificate
- 5) Current valid copy of registration under Shops and Establishment Act.
- 6) Income Tax Returns of last 03 years (2018-19,2019-20,2020-21) & Pan Card copy.
- 7) Detail of T&P required for the said work.
- 8) Valid insurance against workmen compensation act.
- 9) Proof for tender fee

**Proof for Tender fee and EMD Paid / exempted. Tender Fee and EMD is to be paid by online mode only.**

**"Firm/Bidder has to pay E.M.D., irrespective of S.R.M. System asks for the same or not in following cases:**

**i.If S.S.I./N.S.I.C. Certificate do not indicate Material/Service required against present Tender.**

**ii.If Turnover or Manufacturing Capacity exceeds the limit indicated in S.S.I. / N.S.I.C. Certificate specified by the concerned Authority to avail the benefit of E.M.D. exemption.**

**If required E.M.D. is not paid by the Bidder, the Offer is liable for rejection."**

**The original colored scan copy should be uploaded as bid documents in Support of Statutory Qualifying Criteria.**

- 10) The transporter should have own crane of required capacity. Consent letter from other transporter shall not be submitted. Proof of crane Vehicle registration certificate in the name of transporter, taxation payment receipts, etc. of the vehicles which will be use for work under this contract shall be attached.
- 11) ESCI and EPFO registration
- 12) Joint venture will not be allowed.
- 13) InThe **Annexure "A"** duly filled in shall be submitted (in Soft Copy) with **qualifying bid.**

All the terms & conditions are binding & applicable while finalizing the tender. The offer of the bidder not fulfilling the qualifying requirements as above will not be considered for further evaluation and shall be summarily rejected.

- 14) Declaration regarding not been blacklisted/ non forfeiture of EMD/ Security Deposit/ Bank Guarantee in the past in the format given in **Annexure-VII**
- 15) No relation undertaking in the format given in **Annexure –V**
- 16) The bidder shall submit “Technical Bid form” as per **Annexure III**.
- 17) Additional condition of bidder will not be entertained and may be summarily rejected.
