

- 3) Under Techno-commercial bid, the bidder should attach the following digitally signed documents & answer the respective question :
  - 1) Registration certificate under Bombay shop and establishment Act.
  - 2) Valid authorized service/Dealer certificate.
  - 3) E certificate of govt. or private undertaking for similar nature of works at least for one year.
  - 4) GST registration certificate and paid challan
  - 5) Income Tax return file for last 3 financial year ( FY 2017-18, FY 2018-19, FY 2019-20 with PAN copy).
  - 6) If bidder comes in category SSI, MSME & if EMD is not applicable, attach the registration certificate. The certificate should be valid on the date of submission of bid and the validity of the same should be certified by the C.A.(if yes Please Attach)
  - 7) EMD payment receipt, (if yes Please Attach)
  - 8) Undertaking to be submitted by the bidder declaring that bidder is not debarred/blacklisted by government/semi government/ other power utilities.
- 4) The technically qualifying bid will be open first & if found suitable then corresponding price bid will be open for further consideration.
