Terms and Conditions:

- 1) The requirement of driver service is at the office of the Additional Executive Engr Telecom S/dn Kolhapur & Karad.
- 2) The Normal Head quarter and place of reporting for the duties of the Driver for office of the Addl.Exe. Engineer, Telecom S/Dn., Karad shall be Vijaynagar, Karad and driver for office of the Addl. Exe .Engineer, Telecom S/Dn., Kolhapur shall be Kolhapur. Normally, the vehicle will be utilized for Satara, Sangli, Kolhapur, Ratnagiri, Sindhudurg, and Goa district.
- 3) The Driver should possess valid permanent L.M.V. driving license having experience more than 5 years and preferably public badge too.
- 4) The agency should have Govt. labour contract license, independent PF and ESI Nos.
- 5) The agency should be preferably be engaged in the welfare of Ex servicemen and providing gainful employment for them.
- 6) The period of contract is for one year from the date of placement of order or intimation.
- 7) Normal 10 hours duty starts from 9.00 to 19.00 hrs every day and the overtime will be admissible excluding the normal duty hours. Night halt charges shall be payable only if MSETCL vehicle is required to be halted at any place other than the normal head quarter. However, either O.T. or halting charges whichever is less will be paid on a particular day limited to night halt charges.
- 8) Preference will be given to ex servicemen, other things being equal.
- 9) Daily routines & other periodical maintenance of the vehicle should be looked after by the driver.
- 10) Insurance, PF, ESI and Bonus any other financial liabilities etc arising out of whatever circumstances and whatsoever reasons in respect of your labor force shall solely rest with you and MSETCL shall not be responsible for any liability whatsoever.
- 11) MSETCL vehicles are insured for 3rd party risk only.
- 12) In case of accident, any claims arise are required to be borne by you for proven charges of driver's negligence during the discharge of his duties; the same shall be made good by you.

- 13) The Driver should be free from drugs and alcoholic addictions.
- 14) Lubricating oil and diesel shall be supplied by the MSET Company Ltd.
- 15) Cost of spares and maintenance shall be borne by the MSETC Ltd. fully. However if any damages caused by the Driver due to negligence, the cost of the same shall be recovered from you.
- 16) Rates quoted shall be exclusively for driving duty and routine maintenance of the vehicle. The rates shall be valid for 6 months.

- 21) You will have to pay Security Deposit of 5% of the total value of the order within 7 days from the date of receipt of firm order if placed with you.
