1. **DUE DATE:-** The prescribed form i.e. Schedule 'A' duly filled in, with the rates written in words & figures, & signed, should be sent by registered post or in person to the Executive Engineer, MSETCL, Telecom Division, Vijaynagar, Karad on or before 17.00 Hrs. dtd.03.08.2021

3. **OTHER CONDITIONS:-** The offer should be submitted along with following conditions & documents :-

- (a) Rate validity of the offer.
- (b) Pan Card.
- (c) GST registration details.

All the documents of this enquiry Schedule 'A' & above accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection.


- 4. SECURITY DEPOSIT:-** Every Bidder whose Bid is accepted should submit Security Deposit within 7 days from the date of receipt of order / L. O. I. by way of security for the due and proper fulfillment of his contract by Cash or D.D. drawn in favor of Superintending Engineer EHV O & M Circle, Karad. The Bank Guarantee of any Nationalized Bank or Scheduled Bank will be accepted against Security Deposit. The Security Deposit Payable to MSETCL shall be Five Percent (5%) of the amount of the work order. If fail to do so, the S.D. will be recovered from Contractor's first bills with interest at the rate of 18% per annum. Also Contractor will have to apply for refund of S.D. within 6 months after completion of Contract period. If Contractor fails to apply within stipulated period, the actions as per C.O's rule will be taken. The Security deposit will be returned after the completion of the work satisfactorily and submission of No dues certificate or N.O.C. from concerned Engineer In charge by the contractor. No interest shall be payable by MSETCL on the S.D. under any circumstances. S. D. shall not be refunded and shall be forfeited in case of termination due to breach of the contract.
- 5. RATE VALIDITY:** The offer shall be valid for acceptance for a period of 90 days from the date of submission of quotation. During this period no bidder shall be allowed to withdraw his offer.
- 6. PERIOD OF ORDER:** The contract period will be for a period of 1 year only, from the date of issue of order & its implementation. However, the period will be curtailed or extended as per the accepted rates, terms & conditions.
- 7. LIQUID DAMAGES/PENALTY:** In case of failure, to execute the order satisfactorily, you will be liable for penalty @ $\frac{1}{2}$ per delayed week or part there of subject to maximum 10% of the order value. The amount shall be recovered from the bills.
- 8. PAYMENT:** Payment will be made on completion of work and receipt of your bill in triplicate along with calibration certificates to be submitted to this office for payment along with GST registration number etc.
- 9. EXECUTION OF WORK:** Bidder has to make the arrangement for calibration of kits at office of the Executive Engineer, Telecom Division, Karad. The calibration shall be done to the satisfaction of the undersigned. Labour for works will be on your account. Required man power and machinery is to be arranged by you. No material, labour facility shall be supplied by the Company. If the order is not executed completely & satisfactorily, it will be treated as cancelled & the work will be got done either departmentally or from the outside agency even at higher rates & the difference in the rates will be recovered from Bidder's pending bills if any or S.D.
- 10. VALIDITY OF CALIBRATION:** The calibration should be valid for the period of 1 year from the date of calibration.
- 11. QUALITY:** The calibration should be strictly confirmed to the specifications as stated in Schedule 'A'. Also you are required to give calibration certificate for a period of one year for each of these kits.
- 12. GST:** - GST as applicable for service provider's portion, will be allowed in the Tax invoice.
- 13. DISPUTES:** All disputes or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of Karad Court only.

14. **RIGHT OF ACCEPTANCE/REJECTION:** The undersigned reserves the right to accept or reject the order without assigning any reason thereof. The undersigned reserves the right to alter, modify or cancel the above order at any stage if found necessary.
15. **CONDITIONS OF CONTRACT:** All General / Technical / Commercial terms & conditions of the contract of the Company are applicable to this contract & will be binding on bidder.
16. **AGREEMENT:** An agreement is required to be executed by bidder with the company on stamp paper of Rs. 500/-, containing all above terms & conditions of the order before its execution. The cost of the stamp paper should be borne by the bidder.
