Also Contractor will have to apply for refund of S.D. within 6 months after completion of Contract period. If Contractor fails to apply within stipulated period, the actions as per C.O's rule will be taken. The Security deposit will be returned after the completion of the work satisfactorily and submission of No dues certificate or N.O.C. from concerned Engineer In charge by the contractor. No interest shall be payable by MSETCL on the S.D. under any circumstances. S. D. shall not be refunded and shall be forfeited in case of termination due to breach of the contract.
