Rates are called through superscripted sealed quotations from:17/08/2021 to 24/08/2021 upto15:00 Hrs for the works mentioned in Schedule 'A'. The other terms and conditions are as mentioned below.

Terms & Condition

- 1. **PRICES:** -The rates will be accepted as per Schedule A rates with work under EHV O&M Division, Kolhapur.
- 2. **TAXES:** Rates should be quoted in %basis only. Rates in Schedule A are Excl. of GST.
- 3. **DELIVERYPERIOD**: Agency should deliver required material i.e SIREN of required specification **within 1 month** of time span.
- 4. **VALIDITY OF OFFER:**Validity of work order will be 3 month from the date of issue of work order or exhaustion of work order amount.
- 5. <u>GUARANTEE:</u> The works should be guaranteed against manufacturing defects, for a period of 1 year from date of Delivery and this undertaking may be sent along with the bill without fail. For any defects in workmanship/Manufacturer, you will have to give free service within 7 days from the date of intimation within guarantee period.
- 6. **Security Deposit**: You will have to pay Security Deposit 3% of base order value before issue of work order. S.D will be refunded after completion of guarantee period.
- 7. **Scope of work** As per schedule A & as per the specification submitted. Transportation of material and expert manpower will be at your cost only.

- 8. **Penalty**: In case of work is not completed as per schedule i.e within one month, the contractor shall be liable to pay penalty @ ½ % per week subject to maximum 10% of order value.
- 9. All required T&P/ Manpower should be arranged by you.
- 10. You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
- 11. Quality of Materials: The bad quality material will be rejected.
- 12. **Risk Purchase**: In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
- 13. **Payments**:-100 % payment against bill after satisfactory supply of material, certification from concern S/s Incharge, SAP activities & availability of funds.
- 14. In case you fail to carry out the work in part or full, the balance work will be carried out through other agency and difference in cost will be recovered from your bill, Security Deposit.
- 15. All disputes / differences arising under/ out of or in connection with the contract shall be subject to the exclusive jurisdiction of Kolhapur court only.
