TERMS & CONDITIONS:

- 1) Scope of work:** As detailed in **Schedule-B**.
- 2) Quoted rates:** The quoted rates should be consider the cost of items strictly as per specification & test certificates etc. Taxes & Charges shall be mentioned clearly. If not mentioned, rates quoted will be considered as inclusive of all taxes & charges. While submitting the bid the Schedule "B" should be filled in and signed.
- 3) Water filter & prefilter** shall be preferable of make Kent/Bluestar/Eureka/Aquaguard company & Water cooler Preferably of make Usha/Voltas company.
- 4) Guarantee/Warranty Period:** The material supplied shall be guaranteed for a period of 01 year from the date of supply at the storage location. If supplied material found to be faulty within guarantee period, same should be replaced free of cost by the supplier. Further,

- during one year period from supply you should undertake servicing & replacement of part while machine break down if required at your cost.
- 5) The supplier will have to submit Water filter, prefilter, Water cooler specifications in the bid for approval of competent committee.
 - 6) In the event of failure of Supply, the ordered materials will be purchased by MSETCL from the open market at the Risk & Cost of the supplier by forfeiting S.D. amount.
 - 7) **Delivery period:** The material shall be supplied within **30 days** from the date of the receipt of the Supply Order at the various locations as per Schedule-B.
 - 8) **Penalty for Delay:** If you fails to supply the materials within stipulated time period, a penalty will be levied at the rate of $\frac{1}{2}$ % per week on the delayed portion of the material supplied per week delay, subject to the maximum of 10 % of the total value of the order.
 - 9) Bid will be disqualified in case of disclosing untrue and /or false information, or withholding information or part of information.
 - 10) **Payment:** 100% payment will be made in the office of Executive Engineer EHV Projects Division, as per availability of funds.
 - 11) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 3 % of contract value towards Security Deposit (As per CE C&M L no MSETCL/CO/C&M/Pre-T/EE/Pretender/2199 Dt 07.04.2021) by cash or by Cheque/ DD/ FD/ Bank Guarantee of nationalized/ scheduled Bank in the name of the Executive Engineer, EHV Projects Division, MSETCL, Nasik. The S.D. will be refunded after successful completion of 01 year i.e guarantee period.
 - 12) **Validity of offer:** The offer should be valid for a period of **60 days** from the date of quotation /bid submission.
