- 1) Work shall be carried out as per Schedule 'A' enclosed.
- 2) The rates quoted shall be exclusive of all taxes
- 3) Taxes shall be quoted separately.
- 4) Rates quoted shall be valid up to completion of work.
- 5) 100% payment of R.A. bill will be effected in reasonable time after completion of quarterly 6) You will have to pay security deposit of 03% of the total amount of the order.
- 7) You will have to execute agreement bond of Rs.500 & cost of bond should be borne by you.
- 8) Following documents needs to be submitted along with quotation:-

- 1. Details of bidder such as name, address, contact number etc.
- 2. GST registration certificate if applicable.
