- 3) Only Diesel will be supplied by the MSETCL.
- 4) Total budget of order is limited up to Rs. 2,96,758/- (Inclusive of all taxes)
- 5) The vehicle will be utilised on any day throughout the contract period as per the requirement of Addl. Ex. Engineer, Testing Unit, Satara Batch A.
- 6) You will have to pay the security deposit of 3% of the order value within seven days from the date of receipt of firm order.
