Sealed & Superscribed quotations are invited on firm quotation basis for the works indicated in **Schedule 'A'** so as to reach this office <u>on or before 21.09.2021 up to 18.00 hrs</u>. on following Terms & Conditions.

#### **Terms & Conditions:**

A) The offer should be submitted in <u>sealed envelope</u> containing following documents as well as price bid superscribing the subject.

- 1. Proof of valid registration of firm under Bombay shop & Establishment Act.
- 2. Valid Electrical Contractor License
- 3. GST registration certificate
- 4. Photo copy of PAN No. of bidder
- 5. The bidder should submit the Work Experience Certificate for <u>Wiring work in MSETCL</u> <u>only, which should not less than 80% of estimated amount.</u> The work experience certificate issued by the officer not below the rank of Executive Engineer.

B) **Ouotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc. are liable to reject.** Offer on Fax or E-mail will not be accepted. This office will not be responsible for delay in postal transit. <u>The agency should not submit</u> <u>'conditional quotation' such conditional offer shall be liable for rejection</u>.

**1. Scope of Work: -** The scope of work includes removing of Old fixtures and Providing & Fixing of New LED fixture along with necessary material under EHV O&M Div. II, Pune. Supply & fixing of material strictly as per specification mentioned in Schedule "A".

**2.** The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.

3. Validity period of offer should be not less than 120 days from the date of submission of offer.

**4.** The rates quoted should be including transportation charges, labour charges, material charges & all taxes and charges.

**5.** Supervision of work:- the work shall be under the supervision of Addl. Executive Engineer (Admin.) or his representative.

**6. Quality Of Material:-** Quality of work to be carried out should be strictly confirmed to our specification, otherwise same will be rejected and contractor has to redone the same at his cost and risk only. Material Supplied by bidder should be inspected by Addl. Executive Engineer (Admin.) or his representative before starting the work. If Material is not as per given Specifications, then said material liable to reject.

7. Quantities:- The quantities indicated in Schedule 'A' are approximate and may vary at the time of execution of the work as per requirement. The payment will be done for the actual quantity of work done.

8. Security Deposit:- Bidder has to submit Security Deposit @ 5% of the total value of the work order.

**9. Agreement:-** Bidder has to execute an agreement on Rs.500/- Bond paper & cost of agreement to be borne by the agency.

**10. Guarantee:** The work done should be of the best & standard quality & as per specification. The work should be guaranteed for minimum one year. The contractor should attend the trouble if reported within guarantee period at their risk & cost.

**11.** Labour & T&P for the works will be on bidder's account. Required man power and machinery should be arranged by bidder.

**12. Work Completion Period:** The bidder have to complete the work within 90 days from the date of issue of work order.

13. Penalty: - If bidder fails to carry out the work within stipulated time as mentioned above, will be liable to pay penalty at the rate 1/2% per week of order value subject to maximum 10% of the total value of the order.

**14.** If any accident occurs during the execution of work, bidder will be responsible for the same and any expenditure towards medical aid will be on your account.

**15.** The bidder should be fully aware of the M.S.E.T. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.

**16.** All disputes or differences arising under, out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
