

### TERMS AND CONDITIONS

- 1. Due Date:- The RFx, complete in all respects, should be submitted between the period of 14.09.2021, 00:00:01 Hrs to 21.09.2021, 14:00:00 Hrs positively.
- 2. Scope of Works:- Work of emergency tree cutting/trimming of spans under jurisdiction of 400kV Lines Maintenance S/Dn Babhaleshwar under 400KV RS (O&M) Division Babhaleshwar. The detail scope of work mentioned in Schedule 'A'.

- 3. Quoted Rates:- You are requested to quote your unit rates for the items mentioned in the schedule on firm (percentage) basis. (Please quote ex-works price in ex-works field &, applicable GST in GST field).
- 4. Payment: On successful completion of the subjected job 100% Payment will be done. Also RA Bills are accepted and payment against RA bills will be done subject to the availability of the funds. On completion of the job, the bill (in triplicate) should be submitted to the office of the Additional Executive Engineer, 400KV Lines Maintenance Unit Babhaleshwar and after verification & records the bill in SAP i.e. through SES, the original bill along with SES, work completion certificate, Joint measurement report will be sent to 400kV RS O&M Division Babhaleshwar for further auditing & passing of the bills.
- Documents required to be attached along with offer:- Bidder should upload the following digitally scan copies of original documents / Attested documents/ certificates online under technical bid.
- I. The Bidder should be an electrical contractor having a valid Electrical Contractor's license issued by Government of Maharashtra Proof thereof.
- II. The Bidder should be Register under GST Act Proof thereof.
- III. Valid registration under Bombay Shop Act and Establishment Act/ Gram Panchayat NOC or Registration as Industry as applicable.
- IV. In case of a partnership firm, a letter by all partners authorizing any one or more partner/partners to deal with the company regarding this bid /contract.
- V. Agency has to submit the certificate of experience having successfully completed work order for the work of tree cutting / trimming of spans of EHV tower lines OR AMC of EHV Lines maintenance duly signed by the officer not below the rank of Executive Engineer or equivalent in MSETCL/PGCIL or any other government/semi-government organization during last 7 years. Please enclose the proof of work order copy & Experience certificate.
- VI. PAN card & Income Tax Clearance Certificate (last three years) /Acknowledgements of Income tax returns filed (last three financial years) in the name of firm with UDIN number (if applicable).
- VII. Full name of quotation submitting firm & full address of the same.
  - a. Contractors name, permanent address & Address Proof.
  - b. Bank name, bank address, bank account details should be submitted.
- VII. Submission of proof regarding online payment of e-Tender fee & E.M.D. may please be uploaded.

The above qualifying requirement are available in the question format in the RFx. The bidder has to answer all the questions at the time of bidding and also the supporting documents are required above shall be uploaded by the bidder in digitally signed PDF format only. The documents will require digital signature at the time of uploading to the SRM Portal, the bidder has to connect the digital signature key at the time of uploading the qualifying documents/any attachment.

- 7. Rates & Taxes: The Rates quoted should be valid at least for 04 months and should be including of all Labour charges & incidental charges including labour cess but excluding GST as per applicable rate & relevant act. Please quote your GST registration No. on quotation.
- 8. Work completion: The entire work completion period shall be up to one year from the date of issuing the work order. To complete work within time limit agency has to arrange resources.
- 9. Penalty:- If the work is not completed within stipulated period the penalty @ 1/2% per week subject to maximum 10% of the order value of work, will be levied. Loss to MSETCL

- property or equivalent etc. due to your negligence will be penalized & recovered from your bills.
- 10. Work quality: Work quality should be satisfactorily.
- 11. Insurance: You have to submit the comprehensive for work order amount as may be necessary to protect your (contractor) interests & the interest of The MSETCL, against all risk valid up to the work order completion period. It is responsibility of the contractor to takeout all necessary insurance of material/equipment/labour for execution of work for his liabilities direct/indirect and same must be attached with the invoice otherwise 1% on work order value will be deducted from bill.(If any).
- 12. Income tax: Income tax. GST TDS will be deducted as per Govt rules.
- 13. Security Deposit: The Bidder will have to pay security deposit within seven days from the the date of receipt of the LOI, amounting to 03% of the value of the contract in the form DD/FDR/BG/Cash of any Nationalized / scheduled Bank in the name of Executive Engineer 400KV RS (O&M) Division Babhaleshwar to this office valid for one year. The same will be refunded only after satisfactory completion of guarantee period.
- 14. Agreement: The contractor has to execute the bond agreement as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with Rs.500=00 stamp duty before starting of the work.
- 15. The offer shall be valid up to 120 days from the date of opening of the quotation/bid.
- 16. The employees should be duly insured against any such eventuality. Your Labour should be covered under group insurance against electrical / mechanical hazard during the work of contract. In case of accident if any injury fatal or non-fatal is caused to the Labour, MSETCL will not be responsible for any monitory claims arising out of accident. It will be the sole responsibility of agency to arrange for suitable insurance to cover such monitory claims.
- 17. If any type fatal/non-fatal accident occurs, whole responsibility shall be of Bidder/Contractor. MSETCL shall not be responsible for that. Contractor will have to provide safety equipments to his employees.
- 18. Failure to execute the work: If the work is not executed in the stipulated period the MSETCL shall be at liberty without further notice or reminder to the contractor, to get the same work done from any other agency at risk & cost of contractor. If you fail to carry out the work in full or in part, the work will be got carried out from other party even at higher rates and the difference in rate will be recovered from you. In that case MSETCL will forfeit the SD submitted by you.
- 19. Hindrance of work: If the work has to be suspended due to any reason, shut down etc., MSETCL shall not pay any compensation / damage to the contractor towards item like idle Labour, idle machinery, vehicles etc. However, in such case the contractor will be paid for the actual work executed by him under the supervision & measured by concerned Engineer incharge.
- 20. Tools & Plants: -All tools & machinery required will have to be arranged by you at your cost. If the tools & plants are provided by MSETCL on rent basis, the standard rent as per MSETCL rules shall be recovered from your bills.
- 21. Sub Letting of contract: The contract or any part thereof shall not be assigned, transferred, or sub let without the prior written permission of the undersigned. Even if such permission is granted, it shall be the responsibility of the principle contractor to whom the work order was originally issued, to execute the works as per the terms of the contract.

- 22. Termination of contract: The undersigned reserves the right of cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect or undue delay in execution of work / starting of the work.
- 23. General: MSETCL general Terms and Conditions for works are applicable to this contract. The undersigned reserves the rights to accept or reject any or all the Quotation without assigning any reason thereof.
- 24. The disputes, if any, shall be subjected to the jurisdiction of the Ahmednagar Court only.
- 25. The undersigned reserves the right to cancel the SRM E-enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
