TERMS AND CONDITION

- 1) The rates quoted by you should be valid at least for one year & should be including of Labor charges.
- 2) The Agency should be under GST Registration preferably.
- 3) The GST will be paid extra if the contractor has the valid GST Registration. Otherwise the amount of liable GST will be deducted from the bill.
- 4) The work shall be supervised by the Executive Engineer 400KV R/S Dn. Deepnagar-Bhusaval-II & carried out satisfactorily.
- 5) The Vehicle to be provided should be purchased after 01 Jan-17.
- 6) If any accident occurs during the work, the complete responsibility of the accident will be of Contractors. The MSETCL shall not pay any type of compensation for any type of accident.
- 7) The work should be completed within specific period as per order from Executive Engineer. After the receipt of the order/intimation to you, failing which the penalty as per rules will be deducted from your bills.
- 8) Security Deposit being 3% of ordered value will have to be paid in form of cash to this office otherwise it will be deducted from your bill.
- 9) The Income Tax and WCT as per rules will be deducted from your bills.
- 10) 100 % Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in by Dy. EE (O) 400KV RS Deepnagar-Bhusaval-II.
- 11) Only diesel will be provided by MSETCL at the minimum assured average run of 15 KM/litre. If it goes below than that, the vehicle owner should bear the additional expenses on his account & same changes will be deducted from monthly bill.
- 12) The Company will not undertake any responsibility if the RTO formalities are violated by you.
- 13) The vehicle will be hired for one year only or till receipt of Departmental vehicle whichever is earlier.
- 14) The use of vehicle will be as per instructions from Executive Engineer, 400 KV RS Dn Deepnagar-Bhusaval as & when required.
- 15) All terms and conditions as per company's rules including those work in the MSETCL booklet. "Tender and contract for works" are applicable in this case also. Not with standing stated herein, the Company's general terms and condition of contract shall be applicable to this contract also.
- 16) The undersigned reserves the right to reject any or all quotations without assigning any reason thereof.
