- 2) Work shall be carried out as per Schedule 'A'
- 3) The rates quoted shall be on firm quotation basis.
- 4) **License:** - You will have to submit the License copy for the use of the Walky Talky set in the name of Executive Engineer 400kV R.S. Division Alkud(M).
- 5) **Transportation & Transit Insurance:** - The necessary transport & Transport insurance is in your own scope.
- 6) **TAXES & duties:** (TDS of GST) & labour Cess as per rule will be deducted from your bill at source as per prevailing rates. Please quote your GST No. on bills. Also, taxes will be applicable as per the rules.
- 7) You will have to execute the agreement bond on 500/-rupees stamp paper. The cost of stamp paper at your account.
- 8) **DEDUCTION:** -Any amount or amounts which become payable by the contractor to the M.S.E. Trans. Co. Ltd under particular contract may be deducted by the Purchaser from any amount/amounts due or becoming due by him to the contract under the same or any other contract
