Technical Bid.

- Submit the performance /experience certificate for similar nature of works as per "Schedule-A" at any HVDC substation.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

Commercial Bid.

- PAN Card
- GST Registration
- Income Tax return for last one year
- Shop Act License.
- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.

- Net Worth of last 1 year duly certified by Chartered Accountant should not be less than 20% of estimated cost.
- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
- 5. Rfx fee is Rs.105/- including taxes (Is nonrefundable).
- 6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 7. Income Tax will be deducted from contractor's bill, as per Govt. rules
- 8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

9. Scope of work:-

Scope of work includes Servicing, Overhauling of Valve cooling motors & its alignment with pumps during annual outage 2021 at HVDC Terminal Station, Padghe.

- a) 'The company' will hand over all the motors and pumps to the vendor in normal working/healthy condition and it will be the sole responsibility of the vendor to hand over all the motors and pumps in Healthy/Working condition after maintenance and Testing. Any component failure during the process of maintenance and alignment is to be replaced by the vendor free of cost.
- b) Work completion certificate needs to be submitted with the bill.
- c) Vendor must give warranty for 6 months from the date of Maintenance and Alignment.
- d) Vendor must bring all T&P including Polish paper .CRC, Jelly etc. required for maintenance and alignment of valve cooling pumps and motors. No material will be provided by 'The Company'.
- e) Precision of Alignment should be (Toleration:<5tau)
- 10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper of Rs. 500/- (Five Hundred Only) at your cost as per the D.O. ltr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. and Co.'s Adm. Circular no. 207 dtd 17.04.10.. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.

11. Before issue of work order, the contractor will have to pay security deposit of @ 3% of the order value on any scheduled, private or nationalized bank **either by-**

i) F.D.R. or D.D. drawn in favor of MSETCL, Padgha or by

ii) B.G. drawn in favor of Superintending Engineer, HVDC RS (O&M) Circle, MSETCL, Padgha.
