TERMS AND CONDITIONS:

- 1. The EMD and Tender fees is to be paid online on the account of '*The Company*' through website https://srmetender.mahatransco.in. Due Date- 12.10.2021
- 2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- The bidder should submit at least one work order copy equal to minimum 50% or more than Rfx amount. The order should be after 01st April 2016 along with its experience certificate for similar nature of work as per schedule-A.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer.

Commercial Bid.

- PAN Card
- GST Registration
- P.F. Registration.
- Electrical License.
- Shop Act License.
- Income Tax return for last one year
- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.

- Net Worth of last one year duly certified by Chartered Accountant should not be less than 20% of estimated cost.
- List of skilled personnels along with qualifications.
- List of T&P available with the agency for execution of the work.
- Valid Workman Compensation Policy. The contractor shall obtain the insurance policy from M/s. United India Insurance Co. Ltd., or any other general insurer registered with IRDA & having business in India on insurance cum servicing basis in the ratio of 40:60 (i.e. the Govt. Insurance fund @40% and the United India Insurance Co. Ltd., @60% which will be valid for 02(Two) years from the date 01.12.2013) entrusted by Director of Insurance, Govt. of Maharashtra. It will be required before issuing of the work order.

3. Scope of Work:

- Servicing, Overhauling and Testing of LVAC breakers 2000 C and 3200 D type for Pole-1
 & 2 during annual outage 2021 at HVDC Terminal Station, Padghe.
- 'The Company' will hand over all the Breakers in normal working/Healthy condition and it will be the sole Responsibility of vendor to hand over all the Breakers in healthy condition after maintenance and testing. Any component failure during the process of maintenance is to be supplied by the vendor free of cost.
- Work completion certificate is to be submitted by the Vendor after testing and maintenance of Breakers.
- Also vendor should give warranty of six months from the date of Maintenance.
- For execution of work, all T&Ps should be brought by agency personnel during work such as CRC, Polish paper, blower, Jelly, Timing Kit etc& extra material and T&P will not be given by '*The Company*'.
- 4. The Contractor rates should be in percentage (%) based on estimate cost.
- 5. Rates should be valid for 120 days after commercial opening of the enquiry.
- 6. Rfx fee is Rs.105/- including taxes (Is non refundable).
- 7. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 8. Income Tax will be deducted from contractor's bill, as per Govt. Rules
- 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- 10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper of Rs. 500/- (Five Hundred Only) at your cost as per the D.O. ltr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. and Co.'s Adm. Circular no. 207 dtd 17.04.10.. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.

- 11. Before issue of work order, the contractor will have to pay security deposit of @ 3% of the order value on any scheduled, private or nationalized bank either by
 - i) F.D.R. or D.D. drawn in favor of MSETCL, Padgha or by
 - *ii) B.G.* drawn in favor of Superintending Engineer, HVDC RS (O&M) Circle, MSETCL, Padgha.

Same will be refunded after expiry of order period. No interest will be paid on this deposit.
