You are requested to send your offer for providing skilled/unskilled manpower to EHVPD-I, MSETCL, Pune. For making offer the following conditions to be noted:-

- 1. The skilled person to be provided for the post of Office Assistant should have passed graduation examination & should have computer knowledge. The skilled person to be provided for the post of Typist should have passed 12<sup>th</sup> examination & should know Marathi & English typing. The unskilled person to be provided for the post of peon should have passed 4<sup>th</sup> std Examination as per the revised qualifications of MSETCL.
- 2. The skilled / unskilled persons should have clear antecedents & should not have been involved in any criminal case etc.
- 3. The skilled/unskilled persons should be vigilant, alert & respectful & presentable while on duty. They should have good moral reputation & should be free from bad habits like alcoholics, theft etc. They should have weekly off as per rules.
- 4. The working timings will be 10.00 a.m. to 6.15pm for skilled persons & 09.30 a.m. to 07.00pm for unskilled persons & should be followed strictly. The holidays will be as per the company's holiday list for Division/ Sub Division.
- 5. You will have to make arrangement of relievers for weekly off/ leave etc. at your cost
- 6. The contract does not confer any right of employment in Company's services.
- 7. You should quote fixed charges per day except GST & no other charges will be considered. Tax to be mention extra.
- 8. Payment will be made subject to availability of funds.

- i) Three completed work orders each amounting to not less than 20% of the estimated cost of subject enquiry

ii) Two completed work orders each amounting to not less than 30% of the estimated cost of subject enquiry

or

iii) Single completed work orders amounting to not less than 60% of the estimated cost of subject enquiry

or

vi) Work orders cumulatively amounting to 100% of the estimated cost, within maximum of 6 work orders.

### II) Financial Qualifying Requirement

- 1) Proof regarding registration under GST & proof of paid challan and return filing for last financial year.
- 2) Income tax return for the last three financial year.
