Please submit your reasonable offers for Providing and Fixing of wireless projector in the office of Superintending Engineer, MSETCL, EHV O&M Circle, Kolhapur. with following specifications as mentioned in scheduled A.

TERMS & CONDITIONS:

- 1. <u>Due Date</u>: the quotations complete in all respects, dully sealed and super scribed should be submitted to this office on or before 18/10/2021 upto 12:00 hrs positively.
 - 2. You should have to submit the following documents along with sealed quotation
 - I) Proof of PAN Card
 - II) Proof of GST registration certificate
 - III) Brochure/ Design/ Make details/ Photograph etc of wireless projector for which rates are quoted.
 - **3. Quoted rates:** the taxes applicable if any should be quoted distinctly, otherwise rates should be considered as including all taxes.
 - 4. Scope of work: As detailed in schedule -' A'.
 - 5. Estimated cost:- The estimated cost is limited upto Rs.66,400/- (inclusive of all taxes).
 - **6.** <u>Delivery& work completion period</u>: the work should be completed within 30 days from date of issue of work order.
 - 7. Execution of work: In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order Schedule within the time specified in the work order.
 - The said work is to be carried out under the supervision & directives of the Superintending Engineer or his representative i.e.EE (Admin) assigned for the job. The work should be carried out strictly as per Schedule 'A' & upto full satisfaction of the supervising authority.
 - **8.** Sample of wireless LCD Projector with screen (as per Schedule -'A') should be got approved from the Superintending Engineer EHV O&M Circle, Kolhapur within 07 days after receipt of the order. Copy of the approval should be attached along with the bill.
 - 9. Penalty:- In case the materials are not delivered in time, the supplier shall be liable to pay penalty @ ½ % of the price per week delayed, or part thereof, subject to a maximum of 10%. The penalty will be levied subject to force majors' conditions, for which documentary evidence will have to be produced to the satisfaction of the competent authority of the Board. In the event of failure to supply, our Company may purchase the ordered materials at the cost & risk of the supplier in the open market.

- 10. <u>Agreement</u>:-The contractor will have to execute an Agreement Bond on Stamp Paper of Rs.500/- (Rs.Five Hundred Only) at his own cost if order is placed. If any amendments in the execution of agreement bond the same must be borne by the contractor.
- 11. <u>Terms of payment</u>: 100% payment will be effected to you, subject to availability of funds.
- **12.** <u>Payments</u>: the bills in duplicate should be submitted to this office for payment, with necessary documents as Manual, warranty card etc., After duly approved and certified by the concerned authority in the SAP system the same will be reflected subject to availability of the funds at Circle Office. Please quote your GST No. on the bill for smooth payment.
- 13. <u>Guarantee / warantee</u>: you have to furnish the guarantee / warranty of material as per manufacturing standards from the date of receipt of material against any manufacturing defect etc. The understanding as such should be sent along with the bill.
- **14. Quality of materials:** Quality of work to be carried out should be strictly confirmed to our specification & confirming to IS Standard otherwise same will be rejected and contractor has to redone the same at his own cost and risk only. the quality of material should be as per specification in Schedule A.
- **15.** <u>Jurisdiction</u>: all disputes or difference arising out of this order for supply, if concluded shall subject to exclusive jurisdiction of Kolhapur court only.
- **16.** <u>Security Deposit</u>: you have to pay security deposit of 3% of order value in form of cash / DD / BG which will be refunded after completion of warranty period.
- **17.** <u>Consignee</u>: the ordered material should be delivered to the office of SE EHV O&M Circle, Kolhapur.
- **18. Transportation & Residence:** The necessary To & Fro Transportation will be in the contractors scope. Also no any residence facility will be provided by the MSETCL.
- 19. If you fail to supply the material in stipulated time, material will be procured at your risk and cost.
- **20.** MSETCL bears no responsibility of any kind i.r.o. the worker employed for this work & contractor shall be whole responsible to observe & follow all the statutory provisions regarding Labour laws. The rates should be quoted considering applicability of all these aspects.
- **21.** If any damage occurs to the company's property during execution of above work, contractor will have to make them good at his cost.
- **22.** You are also deemed to be fully aware of Company's general conditions for supply of materials.
- 23. Remaining all conditions will be as per MSETCL rules and procedures.
