**Sub:-** Enquiry for inviting quotation for calibration of Digital level meter from OEM (Original Equipment Manufacturer) or Authorized Dealers under Telecom Division Nashik.

With reference to above subject, the sealed and super scribed quotations are invited from OEM (Original Equipment Manufacturer ) or Authorized Dealers for the work as described in schedule "A" enclosed herewith subject to following terms and conditions.

**Terms & Conditions:**

1. **DUE DATE:-** The quotations should be submitted in format of Schedule 'A' duly filled in, with the rates written in figures & words and duly signed should be sent by registered post or in person to the Executive Engineer, MSETCL, Telecom Division, Nashik on or before dt. **25.10.21 upto 17.00 Hrs.**

2. The offer should be submitted in sealed & super scribed envelope with following details.

Quotation for : Work of Calibration of Level Meter & Oscillator Under Telecom Division, Nashik

(Note: Bidder should not submit "Conditional Quotations" such conditional offer shall be liable for rejection.)

3. **Other Conditions:-** The offer should be submitted along with documents:

- 1) Rate validity of the offer.
- 2) Pan Card.
- 3) GST registration details.

All the documents of this enquiry Schedule 'A' & above accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection.

4. **Agreement :** The successful bidder have to execute an agreement within 7 days from the date of receipt of work order/LOI as per provision of "Mumbai Mudarank adhiniam 1958 Clause No..34" with requisite stamp duty before starting of work. The necessary stamp duty & bond paper for the agreement shall be borne by the bidder.

5. **Security Deposit :-** The successful bidder will have to deposit the security deposit of 5 % of the work order value within 7 days from the date of LOI/W.O. at the Office of the Superintending Engineer, EHV O&M Circle, Nashik. The entire security deposit will be refunded to you on satisfactory completion of contract period and as per availability of fund. In case break of contract from your side, before completion of contract period, the security deposit will be forfeited by the company.



6. **Rate Validity** : The offer shall be valid for acceptance for a period of 90 days from the date of submission of quotation. During this period no bidder shall be allowed to withdraw his offer.

7. **Contract validly & Delivery Period** : The contract period will be for a period of six month only, from the date of issue of order & its implementation. However, the period will be curtailed or extended as per the accepted rates, terms & conditions. The delivery period should not exceed 15 days from date of handing over of Digital Level Meter.'

8. **Despatching of material and Execution of Work**: The error born digital level meters shall be sent by respective subdivision in charge under Telecom Division Nashik to agency at MSETCL's cost. The calibration shall be done to the satisfaction of undersigned. The calibration should be strictly confirmed to the specifications for the item mentioned in schedule 'A'. The kit utilized for calibration shall be confirmed to IS standards for calibration. Required manpower and machinery is to be arranged by agency.

9. **Liquidated Damages /Penalty** : In case of failure to execute the order satisfactorily, you will be liable for penalty @ ½% per delayed week or part there of subject to maximum 10% of the order value. The amount shall be recovered from the bills.

10. **Payment** : Payment will be made on completion of work and after receipt of bill in triplicate along with calibration certificates, to be submitted to this office for payment along with GST registration number.

11. **Validity of Calibration**: The calibration should be valid for the period of 3 years from the date of calibration.

12. **Quality** : The calibration should be strictly confirmed to the specifications as stated in Schedule 'A'. Also you are required to give calibration certificate for a period of three years for each of these kits.

13. **GST**: - GST as applicable for service provider's portion will be allowed in the Tax invoice.

14. **Jurisdiction**: In case of difference of opinion, about interpretation of terms & conditions between Agency & MSETCL, the decision of order placing authority will be final & binding on the agency. Also any dispute arising out of contract, it will be in the jurisdiction of Hon. Nasik court only.

15. **Right of Acceptance/ Rejection**: The undersigned reserves the right to accept or reject the order without assigning any reason thereof. The undersigned reserves the right to alter, modify or cancel the above order at any stage if found necessary.

16. **Condition of Contracts** : All General / Technical / Commercial terms & conditions of the contract of the Company are applicable to this contract & will be binding on bidder.
