Scope of Work Includes Following Work to be Carried Out by the Contractor:-

- 1) Quarterly Checking of all A.C. Units including cleaning the air filters, Evaporator coils, electric contacts, machine, motor and other equipments etc.
- 2) Refilling of gas in A.C. as and when required. (Gas Charges inclusive)
- 3) Repairing of burnt compressor / voltage stabilizer if any.
- 4) Sealing of gas leakage if any.
- 5) Checking and repairing of burnt part / wiring if any.
- 6) Checking the duct and repairing thereof.
- 7) Greasing, oiling of moving parts as and when required.
- 8) Attending emergency troubleshooting calls within 48 hrs from called upon.
- 9) Allied works of repairing to keep the A.C. Units in working Condition.
- 10) Spare Parts to be provided as per Annexure "A"

Note:- Spares Parts other than Annexure "A", if required shall be paid extra by MSETCL after verification of Market rates along with extra labor charges.
