## Technical & Financial Qualifying Criteria for the Bidder

- 1) **Turnover:** The bidder should have turnover/completed work of unloading of transformer and accessories worth 50% of tender estimate or more of proceeding three financial years. The bidder should have to produce certificate duly certified by Chartered Accountant in the proforma given in Annexure- VIII  
**Work order copies and Exp. Certificate** for The work of AMC for cleaning and up keeping the premises of Store office and store custody on job basis at Major store wardha 2021-22

- 2) During last 5 years ending last day of month previous to the one in which applications are invited should be either of the following:-

**Experience of having successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders** during last 5 years ending last day of month previous to the one in which applications are invited.

- 3) Current valid copy of **GST** Registration
- 4) Professional Tax Certificate
- 5) Current valid copy of registration under Shops and Establishment Act.
