

## **Terms & Conditions Part - I**

- 1) The bidder is advised to inspect & examine the site and satisfy himself as the conditions prevailing at site and its surrounding regarding extend of work, scope and conditions under which the work is required to be executed.
- 2) Offer should be submitted online in Two bid type. Techno-Commercial bid & Price bid respectively.
- 3) Under Techno-commercial bid, the bidder should attach the following digitally signed documents & answer the respective question :

### **3.1 Statutory Requirements :**

- i) Registration certificate under Bombay shop and establishment Act.
- ii) Registration under workmen compensation insurance policy
- iii) GST registration certificate along with latest paid challan.
- iv) Undertaking to be submitted by the bidder declaring that bidder is not debarred/blacklisted by government/semi government/ other power utilities.

### **3.2 Minimum Technical Qualifying Requirements :**

- i) The bidder should have work orders with satisfactory work completion certificate signed by competent authority not below the rank of Executive Engineer. On certificate Supply/Installation of CCTV camera & Intercom system and servicing/repairing of CCTV camera & Intercom system, period of work completion must be mentioned on the certificate. OR equivalent in case of government or private undertaking.
- ii) The bidder should have last three years experience in the similar works as under :
  - a) Amount of single work order is not less than the 80% of estimated tender amount. OR
  - b) Amount of two work orders is not less than the 50% of estimated tender amount. OR
  - c) Amount of three work orders is not less than the 40% of estimated tender amount.
- iii) Bidder should have authorized channel partnership for Supply/Installation of CCTV camera & Intercom system and servicing/repairing of CCTV camera & Intercom system.
- iv) The MSETCL reserves the right to review the bidders performance in MSETCL or any other Govt. or Private undertaking during last three years and may accept/reject the offer in part or full accordingly.

### **3.3 Minimum Commercial qualifying requirements :**

- i) Tender Fee of Rs. 500/- + GST will have to paid by online mode only.
- ii) EMD in lieu of bid security deposit minimum Rs. 5000/- or 1% of estimated tender amount whichever is higher will have to be paid by online mode only.
- iii) Income Tax return file for last 3 Assessment Years ( AY 2018-19, AY 2019-20, AY 2020-21 with PAN copy).
- iv) If bidder comes in category SSI, MSME & if EMD is not applicable, attach the registration certificate. The certificate should be valid on the date of submission of bid and the validity of the same should be certified by the C.A.



v) Attach Tender fee & EMD payment receipt.

Notwithstanding anything stated above, the purchaser's decision in this regards shall be final. The above qualifying requirements are available in the question format in the RFx. The bidder has to answer all the questions at the time of bidding and also the supporting documents as required above shall be uploaded by the bidder. The documents will require digital signature at the time of uploading to the SRM Portal, the bidder has to connect the digital signature key at the time of uploading the Qualifying documents / any attachment.

**4] Commercial Bid (Price Bid):**

4.1 Bidder should have to quote ex-works price & taxes separately for each items as per the guidelines attached for participating in the RFx.

**Note:-** "The Price Bid shall not be attached in the document format i.e. by preparing the price bid and by uploading / attaching the scan copy of the price Bid. The same will be not accepted".

4.2 First the Techno-Commercial bid will be opened online in respect of all the bids received.

The commercial bid will be opened online in respect of those bidders who have submitted all digitally signed documents/certificates in Techno-Commercial bid as required in satisfactory manner & who are qualified. If any Deviation is observed in the Techno-Commercial bid, the same will be informed you on your registered Email ID in the SRM Portal. You have to submit the compliance /deviation against the same within the stipulated time.

**Note :-** The Techno-Commercial Bid Documents and the Price Bids for the other bidders participated in the RFx can be viewed by you if required for limited time from the opening of the respective bid.

4.3 The Schedule can be downloaded by the bidder by viewing Print Preview in the RFx.

4.4 The rates quoted should be firm and price variation will not be applicable. The offer quoted shall be valid for 120 days. The same is mentioned in the RFx and which is to be accepted by the bidder in the SRM system while participating in the tender. Also, all the Terms and Conditions of the tenders are to be accepted by the bidder through SRM System while participating in the tender.

4.5 A schedule of quantities is included in the tender document. It shall be definitely understood that the company does not accept any responsibility for the correctness or completeness of this schedule and this schedule is liable to alterations, omissions, deductions or additions at the discretion of the Executive Engineer, Major Stores, Panvel, as set forth in the conditions of contract.

4.6 The MSETCL will not pay any extra cost after acceptance of contract.

**5] Disqualifications :**

The bidder may be disqualified due to any of the following conditions but not be limited to :-



- 5.1 Disclosing untrue and /or false information, or withholding information or part of information.
- 5.2 Record of poor performance such as unsatisfactory work or abandoning the work etc.
- 5.3 Financial shortcomings or failures in past contracts.
- 5.4 Insufficient experience, or employing insufficient number of employees, or not employing qualifying employees.
- 5.5 All the schedule of price bid should be fully completed otherwise liable for disqualification.
- 5.6 If bidder quoted rates more than 5% of estimated cost, bidder has to provide rate justification and undertaking to carry out the work. If quoted rates of bidders are found equal, in that case the decision of Executive Engineer is the final and applicable to all the bidder.

6) Firm / Bidder has to pay E.M.D. , irrespective of S.R.M. System asks for the same or not in following Cases:

- 6.1 If S.S.I. / N.S.I.C. Certificate do not indicate Material / Service required against present Tender.
- 6.2 If Turnover or Manufacturing Capacity exceeds the limit indicated in S.S.I/N.S.I.C. certificate specified by the concerned Authority to avail the benefit of E.M.D. exemption.
- 6.3 If required E.M.D. is not paid by the Bidder, the Offer is liable for rejection.


