## Technical & Financial Qualifying Criteria for the Bidder Rfx 7000021022

Tenderer should upload the following digitally scan copies of original documents / certificates online under technical bid.

1. **Turnover:** The bidder should have turnover/completed work of unloading of transformer and accessories worth 50% of tender estimate or more of proceeding three financial years. The bidder should have to produce certificate duly certified by Chartered Accountant in the proforma given in Annexure- VIII
2. **Work order copies and Exp. Certificate** for the Annual contract for unloading with stacking of EHV class material & etc at major Store 'A' Wardha for the year 2021-22. During last 5 years ending last day of month previous to the one in which applications are invited should be either of the following:-  
**Experience of having successfully completed similar works amounting to 60% of the estimated cost in maximum 3 orders** during last 5 years ending last day of month previous to the one in which applications are invited
3. Current valid copy of **GST** Registration
4. Professional Tax Certificate
5. Current valid copy of registration under Shops and Establishment Act.
6. Income Tax Returns of last 03 years & Pan Card copy.
7. Detail of T&P required for the said work.
8. Valid insurance against workmen compensation act.
9. Proof for tender fee

Proof for Tender fee and EMD Paid / exempted. Tender Fee and EMD is to be paid by online mode only.

"Firm/Bidder has to pay E.M.D., irrespective of S.R.M. System asks for the same or not in following cases:

i. If S.S.I./N.S.I.C. Certificate do not indicate Material/Service required against present Tender.

ii. If Turnover or Manufacturing Capacity exceeds the limit indicated in S.S.I. / N.S.I.C. Certificate specified by the concerned Authority to avail the benefit of E.M.D. exemption.

If required E.M.D. is not paid by the Bidder, the Offer is liable for rejection."
