**TERMS AND CONDITIONS**

1. **Scope of Work:** The scope of works includes the supply of 33kV Hardwares, Clamps & Connectors required for 33kV switchyard at 400kV Thaptitanda s/s as per Annexure-A.
2. The unit rates should be quoted on firm quotation basis including cost of materials, all taxes etc. required for supply of material.
3. The material should be supplied from registered vendor of MSETCL for supply of hardwares, clamps & connectors of 33kV Voltage level. Also GST registration, Shop Act, PAN, TIN etc statutory licenses are to be submitted with offer.
4. While submitting the quotation, the contractor should pay E.M.D. of **Rs. 1000/-** by cash or DD of any nationalized/schedule bank in favor of EE, EHV Projects Division, Aurangabad payable at Aurangabad in this office and the money receipt number thereof should be superscribed on the envelope.
5. The firm rates should be quoted in figures and total amount should be quoted in figures as well as in words.
6. An Income Tax & as applicable taxes will be deducted from your bill.
7. The work should be completed within **15 working days** from the date of issuance of work order, failure of which a penalty equal to 1% per week subject to the maximum of 5% of the ordered value will be levied.
8. The work should be strictly carried out as per standard specifications and upto the entire satisfaction of the Engineer-in-charge.
9. The contractor will have to pay security deposit to the M.S. Elec. Trans. Co. Ltd. equal to 5% of the ordered value.
10. The terms and conditions enumerated in the M.S.E.T.C.L's booklet "Tender and Contract for Works" will be applicable in this case and will be binding on the contractor entirely.
11. Right to accept any or to reject any or all the quotations without assigning any reasons thereto is reserved.

12. The quantities enumerated in attached schedule 'A' are approximate and payment will be made against actual supplied quantities.
