ANNEXURE 'A'

Scope of Work

Maharashtra State Load Despatch Centre, a unit of Maharashtra State Electricity Transmission Company having office at Thane Belapur Road, Airoli, Navi Mumbai 400 708 hereinafter called the "MSLDC" acting through the Executive Director (SLDC) wishes to appoint agency for Annual Maintenance Service Contract of IBM X Series Servers hosted at SLDC Airoli (Comprehensive with Back to Back support from OEM & Non-Comprehensive onsite).

Scope of this work includes but not limited to following works

1. The scope of work involves Annual Maintenance Service Contract of IBM X Series Servers hosted at SLDC Airoli. (**Comprehensive with Back to Back support from OEM & Non-Comprehensive onsite**). The specification of the IBM X-Series Servers is given as Annexure C.
2. Comprehensive Maintenance services shall consist of preventive, breakdown and maintenance (Onsite) of IBM X-Series Servers mentioned in annexure C. The maintenance cost shall be inclusive of taxes, labor, Engineer and all other charges.
3. In comprehensive maintenance replacement of defective/worn out part with new, latest part of same or better specification will be free of cost.
4. In Non-comprehensive maintenance replacement of defective/worn out part with new, latest part of same or better specification will be on chargeable basis.
5. Non-Comprehensive Maintenance services shall consist of preventive, breakdown and maintenance (Onsite) of IBM X-Series Servers mentioned in annexure C.
6. **Preventive maintenance Service (Quarterly):** This must be done quarterly for each IBM X-Series Servers. The AMC engineer shall reach site as per the pre-approved schedule and carry out following activities for each material mentioned in annexure C.

During the visit following activities shall be carried out at SLDC Airoli Site

- a. Check system errors, if any and determine the status/health of hardware system and Operating System.
- b. Carry out tests, if required, for proper functioning of the hardware system and Operating System.
- c. Check all the equipment thoroughly using latest diagnostic software of OEM only.
- d. Take back-up of critical files of OS, if required.
- e. Apply patch of Operating System, firmware etc., if any
- f. If any fault is detected during diagnostics then take necessary steps to rectify it and replace it, if required. (Applicable for Hardware and Operating System)
- g. If any errors are observed in error log, analyse them in detail and carry out necessary activities to eliminate them.

- h. Analyze and eliminate the cause of problem/fault, if found any. Systems restart if required.
 - i. In case of any special service is required, AMC engineer will notify the OEM and will co-ordinate with OEM.
 - j. Re-Installation of Operating System, RAID configuration, firmware up gradation if required.
 - k. Prepare an inspection report jointly with MSETCL personal.
7. **Breakdown maintenance (As and when required):** On receipt of call from customer, the AMC engineer shall reach the site and shall carry out following activities.
- a. Check system errors and determine the status / health of the HW system and Operating System.
 - b. Execute tests for proper functioning of the HW , its sub-components and Operating System.
 - c. Execute assessment to determine the current status and diagnose the cause of error (internal or external)
 - d. Diagnose the faults and rectify the defect detected within 24 hrs time. (Applicable for Hardware and Operating System)
 - e. Take action to restore the system to working condition after replacement / repairs of the faulty components / module of the hardware system.
 - f. Repair / replace the faulty parts etc of the equipment. The part to be replace should be Original and from OEM only.
 - g. In case of any special service from OEM required, AMC engineer will notify the OEM and will co-ordinate with OEM.
 - h. Re-Installation of Operating System, RAID configuration, firmware upgradation if required.
 - i. Prepare Fault Clearance Reports / Inspection reports jointly with MSETCL personnel.
8. **Support Levels (SLA)**

Support Window : 24 X 7 supports
Response Time : 2 Hrs.
Resolution time : 24 Hrs.

If the device (Server part) is termed faulty/non-operational, the replacement should take place **within the 24 hours** after the ticket was logged.

The replacement must be with a new device. If it cannot be replaced with a new device, a temporary device has to be installed and made operational at the location. The replacement with the new device should, however, should happen within 48 Hours after the ticket was logged.

Call Registration Process: Telephonic or Email.

The penalties for any non-compliance is defined under Section Terms and Conditions (9).

- 9. The Vendor shall attend unlimited breakdown calls on receipt of complaints. No Spares or any other Items will be supplied by MSLDC in case of comprehensive AMC.
- 10. Well trained engineers for Hardware and Software (wherever applicable) are to be arranged by the Vendor.

11. All spares to be used shall be genuine or compatible spare parts (in that order).
12. Service offered shall be in accordance with the service instructions and standard practice of original manufacturer
13. The Vendor shall maintain service log book and record the nature of service rendered during each trouble shoot by the service representative and the same shall be duly signed by the designated MSLDC IT Person.
14. Vendor shall provide standby Spares/equipment/s and or Hardware in case the Hardware under AMC is down for more than 36 hrs or the problem recurs intermittently after servicing carried out by the Vendor.
15. To co-ordinate with OEMs for support for configuration issues, hardware replacement etc
16. All the above assets are in working condition and are in use which may be verified before commencement of AMC.
17. The vendor shall be solely responsible for the maintenance, repair, replacements and supply of required parts etc. The dismantled parts can be taken by vendor. MSETCL shall not be liable to interact with any of the subcontractors of the vendor.
18. The Vendor shall provide a clear-cut escalation matrix to MSLDC.

ANNEXURE 'B'

TERMS and CONDITIONS:

Bidder should carefully read all the terms and conditions/ Instructions of the enquiry document and follow the same scrupulously.

- 1) Bidder should submit copies of following along with quotation :
 - i. Certificate of Incorporation
 - ii. PAN registration certificate.
 - iii. GST registration certificate.
 - iv. Constitution of bidder's firm (Partnership deed, Articles of Association, MOA etc.) if applicable. However JV (Joint Venture) is not allowed.
 - v. **Experience: Bidder should have Experience of successfully completed similar works during the last Five years ending the last day of month previous to one in which the E-enquiry are invited should be either of following.**
 - a. **"Three similar completed works costing not less than the amount equal to 40% of estimated cost."**
OR
 - b. **"Two similar completed works costing not less than the amount equal to 50% of estimated cost."**
OR
 - c. **"One similar completed work costing not less than the amount equal to 80% of estimated cost."**

(Note - Similar works means Supply, Installation, Support of the Server/AMC of the Servers).

Copy of work order to that effect from concern department/ agency is required to be uploaded at the time of submission of application for tender.

Note: Bids from consortium/Joint venture shall not be accepted. Joint venture/Consortium experience shall not be considered. Experience of only the bidding entity as a prime contractor shall be considered. A job executed by a bidder for his own or project of their Sister concern/Group Company shall not be considered as experience for the purpose of meeting requirement of experience criteria

- vi. Certificate of Registration of Bombay Shop & Establishment Act (1948)/(2018) if applicable.
- vii. Audited annual accounts including balance sheets and other financial statements for **Last three Financial Years** OR Bidder should submit digitally signed ITR from income tax department for last Three financial years.
- viii. Annexures: Annexure E: - Undertaking from Bidder

Failure to provide the desired information and documents may lead to disqualification of the Bidder.

If required MSLDC may verify the authenticity of the documents submitted and if found fake documents or manipulated documents are submitted the vendor will be blacklisted by MSETCL.

- 2) **Security Deposit:** If case order is placed , You will have to pay security deposit amounting to **3% of the ordered value** through FDR/Bank guarantee within seven days from the date of receipt of order otherwise it will be deducted from bill payable. The same will be refunded to you after completion of the contract period, if execution of the order is satisfactory. In the event of unsatisfactory performance of the contract or non-compliance to T&C, Scope of Works this amount will be forfeited. No interest will be allowed on this deposit.
- 3) **Submission of bills and Payment-**You should submit your invoice in triplicate at the end of every Quarter and payment will be made within 30 days subject to availability of fund. Such invoice/s should accompany with OEM Care Pack documentation (for first Bill), Quarterly service report/details of work done and call attendance report certified from IT person. There will be no advance payment against this AMC.
- 4) **Contract Period:** **Contract period will be for 1 Year** After the expiry of the contract period, the service need not be continued taking it as deemed extension of period. The system has to be handed over in full working condition as on the date of the expiry of the contract.
- 5) **In case order is placed, vendor should submit OEM Care Pack Documentation to this office for the contracted period of AMC within 30 days of issue of order. No any bills will be processed without submission of OEM Care Pack Documentation.**
- 6) **Technical Support:** You will provide onsite services for any technical problem in the executed work as per scope of works for the period of **One Year**
- 7) The Annual Maintenance Contract shall cover maintenance of the equipments listed in Annexure –C .The AMC includes routine checks, repairs & replacements of faulty parts, components and all other activities to keep the equipments in working condition at site.
- 8) Prior to the commencement of the maintenance contract Vendor in consultation_ with MSLDC shall prepare the schedule for Preventive maintenance works to be carried out during the entire period of the MAINTENANCE CONTRACT. Vendor shall depute engineer(s) on site as per the prepared and final work schedule
- 9) **Penalty for downtime:**

If case of Non-Compliance of SLA mentioned in Scope of Works, Penalty of Rs. 1000/- per day per faulty Server will be deducted from the bills payable to the contractor.
- 10) The part to be replace should be Original and from OEM only.
- 11) Vendor shall arrange for any additional Manpower required for any assistance whatsoever, required in maintenance jobs during preventive /breakdown maintenance. MSLDC specific help required to be specified by Vendor.

- 12) MSLDC will provide internet connectivity for any Remote support activity.
- 13) One MSLDC Engineer, who is familiar with the System, shall be identified for a single point technical contact.
- 14) **SITE VISIT:** Bidders are advised to inspect, examine the site / equipments and its surrounding and satisfy themselves before submitting their enquiry. A vendor shall be deemed to have full knowledge of the site / equipments whether he inspects it or not and no extra charges consequent on misunderstanding or otherwise shall be allowed.
- 15) Bidder shall be fully equipped to set right the fault within reasonable time, so that the down time of the equipment is minimum.
- 16) The AMC shall be in force for a period of one year. However, the company reserves the right to terminate the contract in case of unsatisfactory work during contract period.
- 17) Vendor is expected to examine all instructions, forms, terms and specifications in this Enquiry document and study the enquiry document carefully. Bid shall be deemed to have been submitted after careful study and examination of this enquiry with full understanding of its implications.
- 18) The firm should clearly mention for any taxes, duties, levies, freight, forwarding and installation for, FSI. Otherwise the rates quoted by the firm shall be considered inclusive of all taxes.
- 19) MSLDC will consider the inability of the Bidder to deliver the services as per scope of work within the specified time limit, as a breach of contract and would entail the payment of Liquidation Damages on the part of the Bidder. MSLDC shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum as specified in Terms and Conditions
- 20) MSLDC reserves its right to reject any or all the offers without assigning any reason thereof whatsoever also reserve the right to re-Enquiry.
- 21) **Acceptance of Bid:** The company does not bind to accept the lowest or any bid neither will any reasons be assigned for rejection of any enquiry. It is also not binding on the company to disclose any analysis report of enquiry.
- 22) **Conditional Bids:**
Conditional bids shall not be accepted on any ground and shall be rejected straightway. If any clarification is required, the same should be obtained before submission of bids.
- 23) If any dispute arises, the decision of the undersigned is final and binding on you.
- 24) **Period of validity of Bids:**
 - a) The bids shall remain valid **for 120 days from the date of bid opening (commercial)** prescribed by MSLDC, MSETCL.

- b) In exceptional circumstances, MSLDC, MSETCL may solicit the bidder's consent for an extension of the period of validity. The request and the response thereafter shall be in writing. A bidder may refuse the request without forfeiting its bid security. A bidder granting the request shall not be permitted to modify its bid. The bid security furnished by the bidder shall also be suitably extended.
- 25) MSLDC, MSETCL reserves the right at the time of award of contract to increase or decrease of the quantity of goods or services
- 26) Any effort by the Bidder to influence the MSLDC, MSETCL in its decisions on Bid evaluation, Bid comparison may result in the rejection of the Bidder's Bid.
- 27) All the software, hardware equipment's like Laptops, tools etc. to carry out the installation has to be brought by the Vendor at no extra cost.
- 28) No extra charges for transportation, T&P, labour, packing, insurance, excise, material etc. will be paid, it will be arranged by you only.
- 29) **Quality of work:** Bidder will be responsible for quality of work and workmanship.
- 30) **Adherence to safety procedures, rules regulations and restriction:**
- i) Bidder shall comply with the provision of all laws including labour and industrial laws, rules, regulations and notifications issued there under from time to time. All safety and labour and industrial laws enforced by statutory agencies and by Purchaser shall be applicable in the performance of this Contract and Bidder shall abide by these laws. The Bidder shall indemnify and keep indemnified and hold harmless the Purchaser for any loss, damage, claims, costs, charges, expenses, etc arising out of and/or suffered on account of actions, litigations, proceedings, suits, arising out of breach of the above laws.
 - ii) Bidder shall take all measures necessary or proper to protect the personnel, work and facilities and shall observe all reasonable safety rules and instructions.
 - iii) The Bidder shall report as soon as possible any evidence, which may indicate or is likely to lead to an abnormal or dangerous situation and shall take all necessary emergency control steps to avoid such abnormal situations.
 - iv) Bidder shall also adhere to all security requirement/regulations of the Purchaser during the execution of the work.
- 31) **Accident:** If any accident occurs to your labour skilled or unskilled, compensation if any, is to be paid by bidder only.
- 32) For any loss to the company's property during execution of work, the bidder will be liable to pay the equivalent compensation as per the recommendation of concerned engineer.
- 33) MSETCL will not be responsible for any accident (fatal or non-fatal) or injury to the personnel of the agency or any financial implication arising there from.

34) In case of new enquiry version creation by MSETCL for any modification in enquiry, bidder is required to resubmit the bid. As existing bid of the bidder gets invalidated automatically in such event.

35) Expenses

- i) Prices payable to the Bidder as stated in the Contract shall be firm and not subject to adjustment during performance of the Contract, irrespective of reasons whatsoever, including exchange rate fluctuations, changes in taxes, duties, levies, charges, etc. However, MSLDC, MSETCL shall be entitled to make applicable deductions including adjustment in the payment of Contract price in the event of levying liquidated damages on the Bidder as provided under the Contract.
- ii) It may be noted that MSLDC, MSETCL will not pay any amount / expenses / charges / fees / traveling expenses / boarding expenses / lodging expenses / conveyance expenses / out of pocket expenses other than the 'Agreed Price'.

36) Force Majeure

Any failure or delay by selected Vendor or MSLDC in the performance of its obligations, to the extent due to any failure or delay caused by fire, flood, earthquake or similar elements of nature, or acts of God, war, terrorism, riots, civil disorders, rebellions or revolutions, acts of governmental authorities or other events beyond the reasonable control of non-performing party, is not a default or a ground for termination. The affected party shall notify the other party of the occurrence of a Force Majeure Event forthwith.

37) Indemnity

Vendor shall indemnify MSLDC and keep the MSLDC indemnified for any loss or damage, cost or consequences that MSLDC may sustain, suffer or incur on account of violation of intellectual property rights of third party by the Vendor. Vendor shall always remain liable to the MSLDC for any Losses suffered by the MSLDC due to any technical error or negligence or fault on the part of the Vendor, and the Vendor also shall indemnify the MSLDC for the same.

38) All the terms and conditions for the supply, testing and acceptance, payment terms, penalty etc. shall be as those mentioned herein and no change in the terms & conditions will be acceptable

39) The enquiry should be completed with all particulars & Annexures. Wherever it is mentioned the enquiry must be signed along with seal. Any document of the enquiry not bearing the signature of bidder is liable to be rejected.

40) In case of dispute, if any, the legal jurisdiction of the court shall be Mumbai only.

41) In case L-1 is more than one, then the Technical qualification of the Bidder will be the criteria and the decision of MSLDC, MSETCL will be final and binding.

42) **General Conditions:** Bidder will be deemed to be fully aware of the MSETCL's General conditions of contract for the supply of plant, equipment and material particularly in respect of security deposits, terms of payment penalty for late delivery etc. Any ignorance of these conditions will not exempt you from your liability to abide by the same. General conditions are applicable as per MSETCL Rules and regulations. Moreover, the right to reject any or all enquiries in part or full without assigning any reason is reserved by the undersigned. Also the

undersigned reserve the right to alter/amend /cancel any or all the terms and conditions stipulated above at any time in the interest of company without assigning any reasons thereof

- 43) The Bidder should have the qualified engineers/ staff to attend the Services at MSLDC, kalwa.

44) Cancellation of Contract and Compensation

MSLDC, MSETCL reserves the right to cancel the contract of the selected Vendor and recover expenditure incurred by MSLDC, MSETCL in any of the following circumstances. MSLDC, MSETCL would provide 30 days' notice to rectify any breach / unsatisfactory progress if:

- Vendor commits a breach of any of the terms and conditions of the bid/contract;
- Vendor becomes insolvent or goes into liquidation voluntarily or otherwise;
- an attachment is levied or continues to be levied for a period of 7 days upon effects of the bid;
- the progress regarding execution of the contract, made by the Vendor is found to be unsatisfactory;
- if the Vendor fails to complete the due performance of the contract in accordance with the agreed terms and conditions.

After the award of the contract, if the selected Vendor does not perform satisfactorily or delays execution of the contract, MSLDC, MSETCL reserves the right to get the balance contract executed by another party of its choice by giving one month's notice for the same. In this event, the selected Vendor is bound to make good the additional expenditure, which MSLDC, MSETCL may have to incur to select and carry out the execution of the balance of the contract. This clause is also applicable, if for any reason, the contract is cancelled.

MSLDC, MSETCL reserves the right to recover any dues payable by the selected Vendor from any amount outstanding to the credit of the selected Vendor, including the pending bills and / or invoking Bank Guarantee / Security Deposit, if any, under this contract.

- 45) MSLDC does not bind itself to accept the lowest or any bid and reserves the right to reject all or any bid or cancel the Enquiry without assigning any reason whatsoever. MSLDC also has the right to re-issue the Enquiry without the Vendors having the right to object to such re-issue.
- 46) Any parts/spares etc required for system restoration in event of Breakdown shall be provided by Vendor.
- 47) Office space and normal office facilities shall be provided by MSLDC.
- 48) All the expenses shall be borne by the Vendor.
- 49) **Travelling Expenses:-** No travelling expenses will be reimbursed or paid to the services & Maintenance Engineers or any other staff for visiting offices of the MSLDC for maintenance work.
- 50) If any accident occurs to the contractor's labor, while on duty, department will not be responsible in any way either legal or financial for the accident to the contractor's labor and

the same shall be at the risk and cost of the contractor. The contractor will have to pay the compensation as per workman's compensation Act to the labors.

51) MSLDC may at its discretion abandon the enquiry process any time before the issuance of Purchase Order.

52) Where there is a discrepancy between the amounts in figures and in words, the amount in words shall govern.

53) Partial Bid will be summarily rejected without giving any reason/notice to the Bidder.

54) No increase, decrease, discount reduction or any other changes in the price will be acceptable after the opening of the quotation.

55) Any variation in the rates, etc. will not be allowed on any ground such as mistake, misunderstanding, typographic etc. after the Enquiry has been submitted. The quoted rate must include all charges including free replacement of spare parts.

56) During the period of contract, no upward revision of charges will be accepted.

57) Income tax, WCT, Labour cess or other statutory taxes if applicable will be deducted at the prevailing rate.

58) Bidder shall abide to M.S.E.T.C.L. standard terms and conditions regarding work contract.

59) Apart from the above points, all the terms and conditions published by MSETCL in booklet "Tender & Contract of Works" are applicable here also.

60) **Signing of Contract Agreement:** In case order is placed, you will have to enter an agreement with MSLDC, MSETCL, in the prescribed format on bond paper of **appropriate Amount** at your cost within 7 days from the date of the receipt of this order as per the D O ltr no. Mudrank- 2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. And Co. 's Adm. Circular no. 207 dtd 17.04.10. The MSLDC, MSETCL will not be liable to pay nor shall you be entitled to claim any bill amount due or payable under the contract until the agreement is executed with MSLDC, MSETCL. The necessary Stamp Duty for the agreement shall be borne by you.
