Sealed & Super scribed **Quotations** are invited so as to reach this office on or before **01.11.2021** for Hiring of Vehicle (Diesel) along with vehicle driver on per day basis for 400KV Lines Projects Subdivision, MSETCL, Babhaleshwar as per enclosed **Schedule 'A'** with following terms & conditions.

Terms & Conditions:

- 1) While quoting the rates, the taxes if any, should be mentioned clearly.
- 2) Income tax at source as per rules will be deducted from bill as per the prevailing rates.
- 3) The rates quoted should be valid for 60 days.
- 4) Only fuel will be supplied by the MSETCL.
- 5) Vehicle registration should be within 5 years.
- 6) You will have to submit copy of documents such as valid registration certificate, Insurance policy certificate, Fitness certificate, tourist permit, Road Tax certificate, driving license, PAN card etc. as per Motor Vehicle Act along with the quotations and produce the original copies for verification whenever demanded by MSETCL authorities.
- 7) 3% Security Deposit is to be deposited in Cash/Crossed DD/Cheque before engaging the vehicle (As per the CE C&M L no MSETCL/CO/C&M/Pre-T/EE/Pretender/2199 Dt 07.04.2021).
- 8) As per provision of 'Mumbai Mudrank Adhinlyam, 1958 clause No.34' an agreement on appropriate value (Not less than Rs.500/-) of stamp paper shall have to be executed with MSETCL for execution of contract satisfactorily before engaging the vehicle. The amount of the fees for such an agreement shall be borne by contractor.

- 9) The MSETCL will not be responsible for any kind of accident or damage during the hired period. All the financial liabilities arising out of accident shall be borne by the owner of vehicle.
- 10) Vehicle must be running on diesel and preferably TATA / Mahindra / Maruti Jeep/car or equivalent and registered with Tourist Permit.
- 11) The mileage per litre of the vehicle should not be less than 18 kms/ltr in case of car type and 12 kms/ltr in case of jeep type
- 12) The working hours will be normally from 09:00 to 18:00 hrs. on working days. However, in case of emergency, it will be required beyond 18:00 hrs or before 9:00 hrs & on holiday also.
- 13) Any kind of vehicle breakdown should be attended by owner. No charges will be paid by MSETCL.
- 14) Driver should be managed by vehicle owner. He should have valid license to drive such type of vehicle.
- 15) All the provisions under rules and laws regarding registration of vehicle, sales tax etc. should be borne by vehicle owner.
- 16) If it is found that vehicle is not giving satisfactory service, it will be treated as breach of contract & contract will be terminated & order will be cancelled by forfeiting the Security Deposit after giving 24 hrs. notice.
- 17) All other standard terms and conditions of the contract prevailing in MSETCL are applicable in the case.
- 18) Vehicle should be able to use on country roads also, where EHV Substation/line works are going on.
- 19) In case of failure of vehicle due to any reason, the vehicle owner has to provide another same type of vehicle on same rate and terms & condition without any delay.
- 20) As per Government of India Ministry of Road Transport & Highways, Fastag is mandatory.
- 21) With 07 days prior notice, the contract will be terminated, if departmental vehicle is made available by MSETCL for this office.
- 22) Prior notice of 01 month will be required if contractor want to terminate the contract during contractual period.
- 23) Right to accept any or to reject any or all the quotations without assigning any reasons thereto is reserved by the undersigned.
- 24) In case of any dispute regarding this contract, the jurisdiction of the court will be Nashik.
