1. The rates shall be offered as per **Schedule "A"**.
2. Validity period of offer should be not less than 90 days from the date of opening of offer.
3. **Time limit:** The total time limit allowed for supply of the above material is within 30 days from the date of receipt of work order.
4. **Penalty:** If the material is not supplied within prescribed time limit, penalty at the rate $\frac{1}{2}$ % percent per week delayed or part thereof subject to maximum upto 10% of work order values will be levied from your bill.
5. **Delivery:** - The material i.e. Common Meter Reading Instrument (CMRI) will be delivered at Sub-Station Maint. Unit , Buldhana. Time being the essence of this order, the delivery period shall be strictly adhered to. The Packing/ Handling & Transportation is in contractor scope. The contractor shall be held responsible for all damages / losses during transportation of material. Further it is instructed to confirm compatibility of CMRI meter before supply with The Addl. Executive Engineer, Sub-Station Maint. Unit Buldhana
6. **Specifications:** Supply of 1 no of Common Meter Reading Instruments (CMRI) compatible with SECURE APEX ABT meter along with allied accessories.
7. **Qualifying Criteria** – Valid PAN card copy, Valid GST registration certificate, Proof of valid registration of firm under Bombay shop & Establishment Act/SSI/ NSIC if applicable & executed work order copy for supply of T&P, equipments meters etc. with experience letter issued by Officer not below the rank of Executive Engineer must be submitted along with the offer.
8. **Submission of Bill:** Bills in triplicate should be submitted to the office of the The Executive Engineer, EHV(O&M) Division, Buldhana along with advance stamped receipt.
