This should contain following documents certificates as a proof of qualifying pre- requisites, brochures, self-attested copy/certificates etc.

5	Work experience certificate / work order copy issued by the competent authority not below the rank of Executive Engineer of similar work along with Certificate of performance / completion of similar work carried out in MSETCL / MSEDCL / other Govt. utilities.

**Note:** If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

1. **SCOPE OF WORK:-** This work for Refilling and reconditioning of fire extinguishers at 400 kV Chakan s/s & as per Schedule – A enclosed herewith for execution further.

2. **PERIOD OF CONTRACT:** The Period of contract will be **two month (60 days)** from date of issue **of LOI or the date of Issue of work order.**

3. **The rates are inclusive of labour charges/transportation etc if applicable & quote as per the schedule 'A'.** However, if the bidder not quoted any taxes, charges separately, then ex-work price will be considered including all taxes and charges.

4. **GUARANTEE:** You should give 12 months guarantee of material. The materials are found defective/faulty due to bad manufacturing within guarantee period, you should be replaced/repaired it free of cost and this undertaking may be sent along with the bill without fail.

5. **PENALTY:-** If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed day, subject to a maximum limit of 10% of the total value of the order.

6. **SUBMISSION OF BILLS: -**

Material shall be carried as per standard specification and the directives of the Engineer in- Charge. Any sub-standard work will not be accepted and payment will not be paid against it. The bill will be submitted in triplicate to 400KV R.S. CHAKAN substation In-charge after satisfactory execution of work.

7. **QUALITY OF WORK & MATERIAL:** Bidder will be responsible for quality of material workmanship. The material used to be strictly as per specification. The required material is to be supplied by you.

8. **GENERAL:** You should make yourself fully aware of M.S.E.T.Co.Ltd.' general condition of Contract for supply of material and execution of work.

9. **PAYMENT:** - Payment will be made to you against after confirmation of work carried out from field in-charge Engineer within reasonable period subject to availability of funds by this office. The auditing will be done at Division office after receipt of bills through concerned section in charge duly recorded in MB. In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.

10. **TERMINATION OF CONTRACT:-** The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.

11. **INCOME TAX & WORK CONTRACT TAX:** -Income Tax & Work Contract Tax (if applicable) will be deducted from the contractor's bill.

12. **AGREEMENT:-** The contractor will have to execute an Indemnity Bond on Stamp Paper of **Rs.500/- at his own cost before commencement of work.**

13. **MOCK Drill (Fire) demo** to be carried out satisfactorily at site location.

14. All general/Technical/Commercial terms and conditions of the contract of the Company are applicable to this contract. The right to reject all or any of the quotation by assigning reason, whatsoever for the rejection of any quotation or all the quotations or to place an order for full quantity or part thereof or to finalize the order on time preferred basis or to split the order quantity wise is reserved with the undersigned.
