#### **Terms and Conditions:**

1) **Prices**: - Rates should be quoted item wise and as per schedule 'A' and for work at various S/s under EHV O&M Dn., Ratnagiri. Taxes/ duties and other levies should be quoted separately. Otherwise, it may be considered as quoted rates are inclusive of all taxes & cess.

#### 2) Qualifying conditions:

- a) Valid fire extinguisher refilling license.
- b) GST registration certificate.
- c) Copy of PAN card.
- d) Order copies along with performance certificate issued by authority not below the rank of Executive Engineer against execution of same type of work.
- e) Registration of firm/shop act license.
- f) Valid workman compensation policy.
- g) Bidders have to submit an undertaking in the attached Proforma 'ANNEXURE-G' declaring that their Firm is not Debarred/Blacklisted by Govt./Semi Govt./Other Power Utilities, anywhere.
- 3) The work is to be attended & completed within 15 days from handing over of equipment/ intimation by the concerned officer.
