- 1. The period for supplying of above material is 30 days from the date of issue of supply order.
- 2. The supply should be carried out with full satisfaction of Engineer-In-Charge including installation, satisfactory testing, etc.
- 3. Quantities mentioned in Schedule "B" are approximate and are liable for variations. However, payment shall be made as per actual quantities executed and measured as per M.S.E.T.C.L.'s rules.
- 4. E-enquiry should be duly filled in all respects and signed & sealed, failing which it will be liable for rejection.
- 5. Quotation fee of Rs.100/- per quotation + 5% GST (100 + 5 = 105/-) Extra will have to be paid online / cash while submitting the offers.
- 6. Successful bidder should have to provide after sale, free service for a period of 6 months from the date of supply.
- 7. In case of any dispute, decision of the Executive Engineer (C) MSETCL, EHV CCCM Division, Sangli shall be final and binding on the contractor.
- 8. Rates quoted shall be inclusive of all the Taxes.
- 9. Validity of rate shall be applicable for 60 days from the date of opening of E-enquiries.
- 10. Income Tax, as per prevailing rates will be recovered from your bill.

- 11. You have to quote your offers considering prevailing rates of GST. If the contractor is registered in GST, it is contractor's responsibility to pay the GST to appropriate Government authority. In case of GST unregistered contractor, GST as per prevailing rate of bill amount will be recovered from the bill and same will be directly paid by this office to Government authority.
- 12. Successful agency have to pay total security deposit 5 % of value of the contract by Cash /NEFT /Online within 7 days from the date of issue of order, in the office of the Executive Engineer (C) MSETCL, EHV CCCM Division, Sangli, otherwise same will be recovered through bills. Same will be refunded after successfully completion of maintenance period of 3 months from the date of completion of work.
  - 13. Agreement As per the rules of MSETCL successful bidder will have to enter into an agreement on stamp paper of amount of Rs. 500/- with MSETCL for the above work as early as possible. Until such agreement is executed with the MSETCL, the MSETCL shall not be liable to pay nor shall the successful bidder be entitled to claim for amount due for payment if any under this contract. Cost of stamp paper shall be borne by successful bidder.
  - 14. Guarantee certificate as per manufacturer's terms & conditions shall be submitted. One year warrantee against manufacturing defects, it includes all the parts of furniture.
  - 15. No any material will be issued by the Company for this work.
  - 16. Other contractual terms and conditions of MSETCL shall be applicable to this contract also.
  - 17. Please furnish zerox copies of your PAN No., Goods & Service Tax Registration Certificate, letterhead & proof of residence, experience certificate along with this e-enquiry.
