**Sub :** E-Enquiry to provide service/labour for attending cable fault on 220kV D/C from 220kV Hinjewadi -III to 220kV Hinjewadi-II Ckt -II at Hinjewadi phase III Pune on urgent basis.

Please quote your lowest rates to attend urgent cable fault on 220kV Hinjewadi III-Hinjewadi II underground line detailed as per “Annexure A” under the terms & conditions given below.

**TERMS AND CONDITIONS :**

1. Rates shall be quoted strictly as per the Schedule “A” enclosed. Any changes if required must be brought to notice of undersigned well in advance.
2. A separate sealed envelope containing Xerox copies of qualifying documents as below is to be submitted mentioning on the top of the envelop **“TECHNICAL BID”**:-
  - i) Shop Act/ Udyog Adhar License/NOC of grampanchayat for shop .The NOC of gram panchayat should valid and recent one
  - ii) PAN No.
  - iii) GST Registration No.
  - iv) Copy of valid electrical agency license.
  - v) Work experience certificate of similar work
3. The rates should be quoted on your firms letter head as per Schedule A in sealed separate envelop mentioning on top of envelop **“COMMERCIAL BID”**
4. Both envelops, should be kept in another big envelop mentioning “Quotation for work of attending 220kV cable fault at on 220kV Hinjewadi III-Hinjewadi II underground line”.
5. Your quotation should reach to this office in person on or before **22<sup>th</sup> October-2021 upto 15:00 Hrs.**
6. Right to reject any or all offers without assigning any reasons are reserved with undersigned.
7. Payment will be made by NEFT/ONLINE payment within 45days subject to availability of funds.
8. No other charges except schedule, will be borne by the MSETCL.

*Enquiry to attend the fault on 220kV Hinjewadi III-Hinjewadi II line.*

9. The T&P for the work will be arranged by the agency.
10. The persons engaged by you must be well trained for above work.
11. **Insurance :-**The agency at his cost shall arrange, secure and maintain comprehensive insurance as may be necessary and for all such amounts to protect his interests and the interest of the Owner, against all risks. Any loss or damage to the equipment, during erection, till such time the plants is taken over by the owner shall be to the account of the agency. The agency shall be responsible for loading of all claims and make good for the the damage of loss by way of repairs and/or replacement of the portion of the works damaged or lost. The transfer of title shall not in any way relieve the agency of the above responsibilities during the period of the contract.
12. **Providing Services / Support**
- i) The agency shall be responsible for any damage to equipment's, property and third party liabilities caused by acts on his part or/ on part of its deployed manpower at MSETCL's premises. In case of any theft or loss of property due to negligence or carelessness of your personnel, agency will be fully responsible and you will have to make good of the losses so incurred to MSETCL, otherwise the same will be deducted from the security deposit or from the payments.
  - ii) MSETCL stands absolved from any liability on account of death or injury sustained by the concerned personnel during the performance of this contract and also for any damages or compensation due to any dispute between the agency and its personnel.
  - iii) Any extra expenditure for getting the work done from other agencies /open market due to the failure of the agency to provide support within the scheduled time as mentioned in the contract / work order will be recovered from the agency through security deposit or pending bills or any other dues payable to the agency by raising claims.
  - iv) MSETCL reserves the right to deduct amount from the bill as may be considered reasonable for unsatisfactory services or delay in providing of services. The decision of MSETCL will be final in this regard.
  - v) This contract is a contract for services and there is no express or implied relationship of employer and employee between agency's employees' representatives and the MSETCL.
13. **Penalty :**The agency shall provide the required service within the period specified in the requisition of the company otherwise the penalty of 0.5 % per week of the value of contract not provided in time will be levied subject to maximum 10% of order value. In case agency fails to provide service to the MSETCL, the contract to agency will be terminated and security deposit will be forfeited. Recovery will also be done for work got done from alternate sources at the risk and cost of the defaulting agency.
14. **Jurisdiction:** All the disputes arising out of this contract shall have exclusive jurisdiction of District court.
15. The agency can visit site & be well aware of site location before participating in bidding process.

16. Work of attending 220kV cable fault at on 220kV Hinjewadi III - Hinjewadi II line must be completed within 08 days from the date of receipt of this work order.
17. **Warranty:** Agency should give 1year warranty for the work
18. **Security :** The agency shall ensure that all his personnel, while in the premises of the company; comply with the company's rules and regulations regarding safety, security, discipline and good conduct.
19. **Security Deposit:** You will have to pay Security Deposit of 3% of the contract price is valid till Dec 2021 as per Circular no. MSETCL/CO/C&M/PreT/EE/Pretender/02199 dt. 17.04.2021 of the proposed value of work order at EHV Projects Division-II Pune within 07 days from placing of order. Also you have to claim refund of S.D. after completion of Warranty period as per clause no.17, otherwise action as per C.O. procedure will be initiated.
20. **Agreement :** Necessary agreement on a Rs. 500/- stamp paper (work order amount limit upto Rs. 1 to Rs. 10 lakh) shall be executed by you at your cost within 7 days from the date of receipt of this work order. Until such agreement is made, neither company shall be liable to pay any amount to you nor you shall be entitled to claim any amount from the company. All the formalities required in connection with the execution of the agreement shall be completed by you in consultation with undersigned.
21. All the MSETCL's general Terms & Conditions will be binding on you.
