- 1) DUE DATE:-** The quotations complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dtd. 06.12.2021 up to 15:00 Hrs** positively. The quotation must be forwarded in sealed envelope duly superscribed with all details i.e. Enquiry No & Date, Due date and Quotation for.
- 2) Enquiry Fees:-** The vendor has to pay Enquiry Fees of **Rs. 100/-** in cash to this office before submission of quotation. The copy of Money Receipt for same attached with the quotation.
- 3)** Tyre to be supplied at Govt. approved rates/lowest rates. The rates should be quoted in words and figures.
- 4) QUOTED RATES:-** The rates are accepted on firm quotation basis including all taxes. The rates are valid for two month from the date of floating this enquiry. GST will be paid extra as per rule in force. According to financial act 194 (c) 1972 income tax will be deducted from your bill @ 2 % of the bill value.
- 5)** The work shall be supervised by Superintending Engineer EHV (O&M), Circle Khadka, Bhusawal or his representative.

- 6) **COMPLETION PERIOD:-** The period of hiring of vehicle shall be normally 45 days from the date of issue of work order.
- 7) **PAYMENT:-** Payment will be by A/c payee cheque affected after completion of work i.e. conformation of delivery of material & as per availability of funds. The bill in triplicate for work carried out should be submitted to this office for payment purpose 100% payment will be effected after observing all formalities.
- 8) Please quote your PAN. No and GST No. on your quotation /Bill, otherwise, Taxes as per rules will be deducted from your bill.
- 9) **SECURITY DEPOSIT:-** As the supply of material is one time, security deposit waived off.
- 10) The Income Tax & work Tax as per rules will be deducted from your bills.
- 11) **DELIVERY PERIOD: -** You will have to supply material within 15 days from the receipt of the work order.
- 12) **PENALTY: -** If the supply is not completed within the stipulated time limit, penalty will be charged at 0.5 % per day subject to 10% maximum of the order value.
- 13) **APPROVAL OF SAMPLE:-**The material shall be subject to approval of the Addl. Executive Engineer (HLU), EHV (O&M) Circle, Khadka- Bhusawal. No bulk supply should be affected before approval of sample.
- 14) **Warrantee: -** Goods supplied shall be warrantee for twelve months from the date of supply. The certificate as such should be sent along with the Tax Invoice. Any manufacturing defects observed in the material within this period, will have to be replaced free of cost.
