Sealed and super scribe quotations are invited for the transportation of material from various site stores of EHV Lines Project S/Dn, Panvel to Bhingari site stores.

Enquiry Period: 29.11.2021 to 07.12.2021.

As per Annexure "A". The quotation should reach this office on or before 16.11.2021 at 18.00 hrs.

Technical & Financial Criteria:-

- 1) The bidder must have executed such type of work as mentioned in the subject work.
- 2) The bidder should submit the license in his/her name for licensed vehicles for transportation of material.
- 3) The bidder shall submit IT returns for last 3 years.
- 4) The bidder should provide certificate of registration under GST.
- 5) The bidder should provide copy of PAN Card.
- 6) The bidder has to pay an EMD of Rs. 500 in the form of cash at the undersigned office. As per the circular published by corporate office in r/o exemption of EMD for SSI&NSIC unit, it is to indicate the following condition in field tender or enquiry is as follows:-
 - "Firms /bidder has to pay E.M.D., irrespective of S.R.M. system asks for the same or not in following cases:-
- I) If S.S.I./N.S.I.C. certificate do not indicate material/services required against present tender.
- II) If turnover or manufacturing capacity exceeds the limit indicated in S.S. I/N.S.I.C. certificate specified by the concerned authority to avail the benefit of E.M.D. exemption. If required E.M.D. is not paid by the bidder, the offer is liable for rejection."
- 7) Time limit allowed for the completion of above work is <u>15 days</u> from the date of issue of LOA.

- 8) Bill :- The bill in triplicate should be submitted through Concerned Sub divisions & payment will be made subject to the submission of bills with required documents from you and certified by Engineer in charge.
- 9) In case of delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance supply, if any shall be got completed through separate contract at the risk and cost of the tenderer.
- 10) The work should be carried out as per standard and to the satisfaction of the Engineer-Incharge.
- 11) All tools & plants required for the work shall be arranged by contractor at his own cost.
- 12) The work shall be supervised by Addl Ex. Engr., EHV Lines Projects S/Dn.. Panvel. The contractor should obtain a certificate from concerned Sub divisions for execution of work satisfactorily.
- 13) The bidder should quote its basis rate in the attached "Annexure A" and rates should be firm and should include all types of taxes, etc. Also mention the SAP vendor number on quotation.

The undersigned reserves the right to reject any or all the quotation without assigning any reasons thereof. Any term and conditions found necessary at a later stage will be published separately.

Notwithstanding anything stated above, the undersigned decision in this regards shall be final.
