#### **Terms and Conditions:**

- 1) DUE DATE: The bids complete in all respects should be submitted to this office on or upto <u>10.12.2021</u>
- 2) QUALIFYING CONDITIONS:
  - a) Proof of firm being registered as shop establishment/firm/Company as applicable.
  - b) Valid GST registration certificate.
  - c) Copy of PAN/TAN
- SCOPE OF WORK: The scope of work consists of "Work of supply & installation of Electrical appliances for various EHV S/s, Subdivision & Division Office under EHV O&M Division, Ratnagiri" as indicated in schedule 'A' attached.
- 4) VALUE OF WORK: The overall contract value of the work entrusted to you, is limited upto Rs.198270/- (Rs. One Lakh Ninety-Eight Thousand Two Hundred Seventy only), including all taxes, duties and incidental charges.

No.) with Guarantee certificate to this office, 100% payment will be made in reasonable time subject to availability of funds. No advance/ part payment will be made.
- 10)CONSIGNEE: The ordered material should be delivered to EHV O&M Division, Ratnagiri office within 45 days from the date of dispatch of work order as per schedule 'A'.

33kW, 4 Ltr./Hrs. Distilled water plant should be delivered & installed at EHV Substations under EHV O&M Dn., Ratnagiri as per Annexure 'W' within 45 days from date of dispatch of work order.

- 11)DISQUALIFICATION: Bid shall be disqualified for following case:

- 14)Other standard terms and conditions of MSETCL for supply orders will be applicable in this case also.
- 15)TAXES: GST as applicable is included in the work order value. Taxes viz. Cess, Income tax will be recovered as per prevailing rates from your bill. You should mention PAN No. & GST No. on your bills.
