TERMS AND CONDITION.

- **1. Rates**:- Rates quoted shall stand firm at least for two months.
- **2.** Taxes: Rate should be quoted inclusive of all taxes.
- **3.** All taxes will be applicable as per rule.
- **4. Pan Card**: PAN Card Number and Xerox copy of PAN, Valid Shop Act Certificate, GST Registration Number should be enclosed along with quotation.
- **5.** No advance payment will be made for this work.
- **6.** Bidder should not submit 'Conditional Quotation'. Such conditional offer shall be liable for rejection.
- 7. The rates should be quoted in figures as well as in words.
- **8.** Completion period: 30 days from the date of issue of order.
- **9. Payment**: The payment of the bill will be made within reasonable time after receipt of bill to this office.
- **10. Penalty:** If the supply is not executed within stipulated period, the penalty @ 1/2% per week on delayed portion maximum to 10% of order amount shall be levied.

The Security Deposit will be returned to the Contractor without any interest for 01 year from the date of Completion of Video Conferencing System.
