The offer should be submitted in sealed envelope containing documents as well as price bid super scribing the subject. This should contain following documents certificates as a proof of qualifying pre- requisites, broachers, self-attested copy/certificates etc.

 SCOPE OF WORK:- This tender is Annual contract for work of weed control chemical treatment in 400kV, 220kV, 22kV S/Yard area & 22kV Cable Yard area. At 400kV R.S. Chakan, as per Schedule – 'A' enclosed herewith of 400kV R.S. division Chakan (Here in after referred to as the Company).

- 2) **PERIOD OF CONTRACT:** The total period of contract is **12 months (Bi-Monthly)** from the date of receipt of order or intimation given by this office.
- 3) VALIDITY of bid: All responses shall be open for acceptance by the Company for a period of 90 days from the date of opening of the quotation and the agency shall be bound to carry out the work on such acceptance within this validity period. All bids submitted against this tender shall be deemed to comply with the conditions unless otherwise agreed by the Company.
- 4) <u>**PENALTY</u>**:- If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed day, subject to a maximum limit of 10% of the total value of the order.</u>
- 5) SUBMISSION OF BILLS: The R.A. bills for the work as per Schedule 'A' along with monthly visit report duly signed by sub-station in-charge should be submitted in triplicate on the name of Executive Engineer, M. S. E. T. C. L. 400kV Receiving Station (O&M) Division, Chakan to concerned Engineer-in-charge. The M.B. recording of the bills will be done by Engineer-in-charge. After receipt of bills from the concerned Engineer-in-charge, auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds. The monthly visit report duly signed by the Engineer-in-charge & the representative of the contractor and the work completion report stating the details of work done by the contractor Bi-monthly should be submitted along with bills.
- 5) **QUALITY OF WORK:** Quality of work to be carried out should be strictly confirmed to our specification, otherwise it will be rejected and contractor has to redone the same at his cost and risk only

The work carried out by the contractor if found defective due to bad workmanship, that should be redone by contractor free of cost, if reported

The prior permission from the concerned Engineer-in-charge is to be taken by the Contractor before starting the work. The work should be executed as per Schedules enclosed and as per instructions of the concerned Engineer-in-charge.

- 6) **GENERAL**: You should make yourself fully aware of M.S.E.T.CoLtd.'s general condition of contract for supply of material and execution of work.
- 7) **<u>PAYMENT</u>**: Payment will be made to you against after confirmation of work carried out from field in-charge Engineer within reasonable period subject to availability of funds by this office. The auditing will be done at Division office after receipt of bills through concerned section in charge duly recorded in MB.
- 8) In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
- 9) <u>TERMINATION OF CONTRACT</u>:- The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- **10) INCOME TAX & WORK CONTRACT TAX:** Income Tax & Work Contract Tax (if applicable) will be deducted from the contractor's bill.

- 11) AGREEMENT- The contractor will have to execute an Indemnity Bond on Stamp Paper of ₹. 500/- at his own cost before commencement of work.
- **12.** All general/Technical/Commercial terms and conditions of the contract of the Company are applicable to this contract.
- **13.** The right to reject all or any of the quotation by assigning reason, whatsoever for the rejection of any quotation or all the quotations or to place an order for full quantity or part thereof or to finalize the order on time preferred basis or to split the order quantity wise is reserved with the undersigned.
