**TERMS AND CONDITIONS :**

- 1) The quotations should reach to this office on or before **03.01.2022 upto 16.00 Hrs.** This office shall not accept any responsibility for late receipt of quotations due to postal delay
- 2) The contractor has to furnish GST Registration, PAN No. in the quotation.
- 3) The bidder should have an experience in execution of similar work. either in transportation work or erection of Transmission lines or Substation.
- 4) **The rates quoted by the bidder, shall be considered inclusive of GST @5% for item no.(1) & GST@ 18 % en item no. (2) & (3)and all other duties, taxes, levies viz. WCT, IT, LW Cess etc. which are payable by the contractor as per statutory regulations.**
- 5) **The bidder shall quote his rate in column no. 5 mentioned in schedule 'A'.**
- 6) Income tax shall be deducted from the bills at prevailing rates.
- 7) The offer shall remain valid for 60 days alter the due date .
- 8) **Security Deposit :**  
Within Fifteen (15) days of the receipt of notification of award i.e. the letter of intent from the Employer, the successful bidder shall furnish the security deposit amounting to 5% of the contract value by cash/ cheque/DD.
- 9) The security deposit shall be returned after settlement of final bill and NOC from the S.D.O.
- 10) **Period:** The time period for completion of the item under Schedule 'A' under this contract will be **90 days**. The period shall be entitled from date of intimation from this office.
- 11) If the work is not completed within stipulated period, the liquidated damages shall be levied at ½ % (half percent) of the total contract price per week of delay subject to maximum of 10% (Ten percent) of the contract price for the entire scope of work.
- 12) **Payment:** 100% of bill for work shall be released after completion of the work satisfactorily. Payment will be effected by cheque by Division office after satisfactory completion of.




- 13) Payment will be made at Division Office, Kolhapur for the work carried out by the contractor for all approved works executed as fixed by the Engineer after proper measurements and scrutiny of bills at concerned Sub-Division Office, after completion of 100% work.
- 14) The contractor has to execute the agreement on stamp paper as per Govt. rule, before commencement of work.
- 15) Addl. Exe. Engr., EHV Substation Projects Sub Dn., Kolhapur will act will act as operating officer for this contract and instructions should be obtained from him as and when necessary for execution of the work.
- 16) All T & P, Labour, Vehicles, Crane etc. shall be arranged by the contractor at his own cost.
- 17) For transportation of material charges for 10 MT shall be paid for each trip for any load upto 10 MT. However, for loading unloading the charges at actual shall be paid.
- 18) For transportation of material, minimum charges for 50 KM shall be paid for each trip for any distance less than 50 KM. However, for the distance more than 50 transportation charges shall be paid at actual.
- 19) Before the commencing the execution of the works, the contractor shall ensure against his liabilities for all material, workmen, physical damage loss or injury which may occur to any property, including that of the employer arising out of the execution of the works on in the carrying out of the contract.
- 20) The contractor shall make his own arrangements for the engagement of all labour local or otherwise and save in so far as the contract otherwise provides, for the transport, housing, feeding and payment thereof.
- 21) The bidder is advised to visit and examine the Site of Work and its surrounding and obtain for himself, on his own responsibility, all information that may be necessary for preparing the bid and entering into the Contract. The cost of visiting the Site shall be a bidder's own expense.
- 22) The contractor shall not submit the work awarded on him under this contract.
- 23) Quotation incomplete in any respect shall be rejected.
- 24) Executive Engineer reserves the right to reject any or all the quotations without assigning any reason therefore.
- 25) Quotation received late or with incomplete details against above clauses will not be considered.
