- 6. Payment will be effected by this office by RTGS or online mode after satisfactory completion of work.
- 7. The undersigned reserves the right to reject any or all the quotations without assigning any reasons whatsoever.
- 8. In case the material is not received and installed within time, the right to cancel the work order is reserved with this office.

- 9. Penalty about ½% Per week or part thereof and maximum up to 10% of the order value for the delay in supply & installation of machine will be charged after stipulated period of completion of work.

The material of ESSL make or equivalent standard make in all respect shall incorporate the highest quality of modern design and workmanship and should give satisfactory and efficient performance under guarantee Period. If any part is found to be defective then the same shall be replaced by you immediately at your cost.
