Terms and Conditions:

- 1) **Due Date**: The quotations complete in all respects, duly sealed and super scribed should be submitted to this office on or before **25.01.2022**.
- 2) Value of work: The overall contract value of the work entrusted to you, is limited upto Rs.1,29,500/- (Rs. One Lakh Twenty-Nine Thousand Five Hundred only) including all taxes, duties & incidental charges.
- 3) Scope of work: As detailed in Schedule 'A'.
- 4) Qualifying conditions:
 - a) GST registration certificate.
 - b) Copy of PAN card.
 - c) Experience certificate of completion of Providing water tanker at Subdivisions/Offices of Govt./ Semi Govt. utilities issued not below the rank of Executive Engineer or equivalent.
- 5) **Rates**: The quoted rates should include the cost of material, all skilled and unskilled labour and also the requisite T&P, incidental charges etc. You are requested to quote your unit rates for the items mentioned in the schedule enclosed herewith. The rate should be inclusive of all taxes/ all applicable taxes and their charges should be mentioned separately & clearly in percentage.
- 6) **Payment**: 100% payment will be effected within reasonable time after satisfactory work completion from our EHV O&M Division Ratnagiri.
- 7) **Security Deposit**: The successful bidder will have to pay an amount equivalent to 5% of the contract value towards security deposit after receipt of LOI in form of cash/DD/FDR/BG of any Nationalized/ Schedule Bank in the name of Superintending Engineer EHV O&M Circle Kolhapur, payable at Kolhapur valid for equal to or more than one year. S.D. will be refunded only after successful completion of work.
- 8) **Agreement Bond**: The contractor will have to execute an Indemnity Bond on stamp paper of Rs.500/- within 7 days at his own cost after receipt of work order.

- 9) Validity of offer: The offer should be valid for our acceptance for period of 60 days from the date of opening the same.
- 10) **GST** Registration certificate if applicable will be provided otherwise undertaking of not registered under GST to be submitted & PAN No. should be quoted in the quotation.
