Online bids are invited in two bid system for SRM E-enquiry for supply & installation of RO(RO+UV+TDS controller) Water purifier with water cooler for various Substation under EHV (O&M) Division Pimpri Chinchwad, Pune **on or before 28.01.2022,18:00Hrs** on following terms and conditions:-

**TERMS AND CONDITIONS**

**Submission of bid**

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in/>

**A. Techno –Commercial bid:**

This should contain following documents certificates as a proof of qualifying pre-requisites, brochures, etc.

1. Scanned copy of EMD & tender fee receipt. (**\*Please refer clause No. 04 & its sub clauses.**)
2. PAN Card & I.T return for the year AY 2019-2020, AY 2020-2021.
3. Proof regarding GST registration.
4. Valid shop act & establishment registration or NOC of Grampanchayat or Udyog Aadhaar certificate.
5. Details of work order / experience certificate issued by the competent authority not below the rank of Executive Engineer **for similar work** in MSETCL/MSEDCL/any other Govt. /PSU organization/OEM.

All general / technical/ commercial terms & conditions of the contract of the company are applicable to this contract.

**If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.**

## **B. Commercial bid:-**

Bidder should upload the digitally signed price bid under commercial bid online.

1. Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tender fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
3. The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
4. **Earnest Money Deposit:** - EMD should be paid on or before due date online only and scan copy of Transaction ID received after online payment should be submitted along with Technical Bid. Request for exemption from EMD shall not be considered on any grounds. In case of failure to do so, the tender is liable to be rejected. Request for payment of EMD after closing of tender and considerations of the tender thereby shall not be entertained.

Earnest money deposit will be refunded online through SRM System after approval from the competent Authority. EMD will be credited to the bank account maintained by the bidder in vendor Profile in SRM system. **Bidders are requested to ensure that the bank details; i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address etc. are correctly maintained in SRM System and update the same, if required.**

### **It may be noted that:**

- a) In case bank details are not maintained by the bidder in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay or any other conflict related to the said issue.
- b) MSETCL will not be responsible for any financial implications in case if incorrect bank details are maintained by the bidders; as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.

**Above Note is incorporated in the Tender Documents to ensure successful refund of EMD to the eligible Bidders and to avoid any legal complications.**

**Exemption from paying EMD and tender fees to Micro & Small Enterprises in following cases:-**

1. The micro and Small enterprises (only manufacturing and Service enterprises) as defined in MSMED Act 2006 are exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar registration certificate submitted by said enterprises should indicate the same Material/Service as required against the tender floated.
2. **The bidder has to pay EMD and tender fees in following cases,**
  - A. If the Micro/Small enterprises Registration Certificate does not indicate the relevant classification code covering Material/Service as required against the tender floated.
  - B. If the investment in Plant and Machinery or Equipment exceeds the threshold limit indicated in the MSMED Act, 2006 (at present the threshold prescribed limit being for Micro- up to Rs. 25 Lakhs, Small :- 25 Lakhs to Rs. 5.00 Cr. As investment in Plant & Machinery and for Micro- up to Rs. 10 Lakhs, Small: - Rs. 10 Lakhs to Rs. 2 Cr. As investment in Equipment).
3. In case of work contract, if the Micro and small enterprises submit that the enterprises shall supply all the materials of intended Work contract, **manufactured from its own unit**, then it shall be eligible for exemption of payment of EMD & tender fee to MSETCL. However, an undertaking duly notarized from Micro and Small Enterprises to this effect is to be submitted along with bid.
4. The works contractors except as stated above and traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or tender fees while participating for e-tender process at MSETCL
5. The registration certificate as submitted by micro and small enterprises should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountant in practice.

**Note:-** In case, the micro and small enterprises (who have been exempted from payment of EMD/Tender fees) does not accept the tender being L1, then such micro and small enterprise shall be debarred from the bidding process for all tenders at MSETCL for next 2 years from the date of non-acceptance of L1 bid .

**3. The EMD is liable to be forfeited under following conditions:-**

- a. In case the tender is withdrawn after the tender submission time or after the date of tender opening, but before expiry of the validity period.
  - b. In case, the tenderer refuses to accept the order placed during the validity period.
  - c. In case tenderer fails to pay the prescribed Security Deposit against an order placed within the validity period.
5. No interest shall be allowed on the EMD in respect of unsuccessful tenders. The EMD will be refunded after the tender is finalized and after producing the transaction document of payment of E.M.D. to the Company, duly discharged in favor of the Company.

6. **WORK COMPLETION PERIOD:** The work should be completed within 45 days from the date of issue of work order and as per instruction of Executive Engineer or Engineer Incharge.
7. **VALIDITY:** validity of the order is upto one year from the date of issue of order or exhaust of order amount.
8. **AGREEMENT:** You will have to execute the agreement bond with Executive Engineer, EHV O & M Division Pimpri Chinchwad, Pune on stamp paper of 500/-. The cost of stamp paper will be borne by you
9. **SECURITY DEPOSIT:** You have to pay security deposit within 7 days from the date of issue of the work order, amounting to 5% of the value of the contract in the form of D.D./FDR of any Nationalized/ scheduled Bank in the name of EE, EHV O&M Pimpri-Chinchwad Division, Pune, payable at Pune valid for one year or by NEFT/RTGS.
10. **QUALITY:** The work should be carried out as per satisfaction of concerned Sub-station Incharge & as per schedule ' A', otherwise same will be rejected and you will have to replace / repairs at your own risk and cost only.
11. **PENALTY:**
12. **PENALTY FOR LATE EXECUTION OF THE WORK:**
  - i. **Performance of work:** If it is found that performance of work is unsatisfactory, or not as per norms of MSETCL the contract is liable for termination at any stage of work without giving any prior notice and at contractor's entire risk & cost. The security deposit paid by agency shall be forfeited in that case.
  - ii. **Delay in execution of work:** If the agency fails to complete the work within stipulated Time, penalty @ ½ % per delayed week, maximum to 10% of order amount shall be levied on contract value. If the work is not carried out in the stipulated period, the works will be got done departmentally or from any other agency at your risk and cost even at higher rates, in addition to the penalty that shall be chargeable as mentioned above.
13. If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed hour in emergency work or per day as applicable, subject to a maximum limit of 10% of the total value of the order.
14. **GUARANTEE:** The work as a whole shall be guaranteed for trouble free service for period of 12 months from the date of work carried out. If supply material found defective due to bad design or workmanship that should be replaced by you free of cost within 2 days or otherwise same will be deducted. **Guarantee Certificate should be enclosed with the bill.**
15. **GENERAL:** You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
16. **PAYMENT:** You have to submit the bill in triplicate along with delivery challan of material to respective Sub-station Incharge. Payment will be made to you against after confirmation of work carried out from respective Sub-station Incharge. Service entry/MIGO of the bills will be done by respective Sub-station Incharge. Scrutinizing & auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.

17. If any accident occurs to contractor's labors, supervising staff during the execution of work, then contractor will be responsible for the same and if any expenditure done towards medical aid, compensation if any will be on contractor's account.
18. **GST Payment**: 100% GST payment will be done against invoice submission.
19. In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
20. **The undersigned reserve the right to cancel tender/ work order at any time during the period of contract without mentioning any reason.**
21. **FORCE MAJEURE**: Only the following conditions shall be considered for the purpose of this clause.
  - a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc
  - b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
  - c. The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof
22. **TERMINATION OF CONTRACT**:- The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period , if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor. Undue delay in completion of contract work is also liable to getting the work done through other agencies at the risk and cost of the contractor.
23. **Jurisdiction**: All dispute or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE court only.
24. **WORK CONTRACT TAX**: As per prevailing rates will be deduct from your bill, if applicable.
