

- 2. E-ENQUIRY FEES :-** Agency should have to pay Rs.105/- (Rs.100+5% GST) against E-Enquiry quotation fees by Cash/Online to EHV O&M Circle Office Karad & copy of the money receipt should be attached with the quotation & submit to this office.
