- 4. Material should be as per the specification detailed in Annexure-A & of genuine make only.
- 5. Conditional quotation will be liable for rejection.
- 6. Security deposit: You will have to pay security deposit @ 5% of total work order value immediately after award of work order valid for a period of 1 year.
- 7. Agreement: As per MSETCL rules, you have to enter into a contract agreement on Stamp paper costing Rs.500/- for this contract immediately within 7 days from the receipt of LOI. Cost of bond paper is to be born by you.
- 8. Following self attested documents must be enclosed with the quotations.
 - a. Proof of firm registered under Bombay Shop & Establishment act
 - b. Copy of PAN card
 - c. Copy of GST registration certificate
- 9. If any damage is occurred to the contractor's equipment/T&P OR any accident to your labours/personnel, the M.S. Elec. Trans. Co. Ltd. will not be responsible in any way. Also if any theft/loss of material is occurred, the M.S. Elec. Trans. Co. Ltd. will not be responsible in any way.
- 10. An Income Tax & as applicable taxes will be deducted from your bill.
- 11. The work should be strictly carried out as per standard specifications and upto the entire satisfaction of the Engineer-in-charge.
