TERMS AND CONDITIONS:

- 1. The EMD and Tender fees is to be paid online on the account of MSETCL through website https://srmetender.mahatransco.in. Due Date- 03.02.2022 upto 23:59 hrs.
- 2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the performance/experience certificate along with work order for
 - Repair, Testing and Refilling work of Various Fire Extinguisher Cylinders for any EHV Sub-station in India
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the supply order mentioned in the experience certificate.

Commercial Bid.

- Income Tax Return for last one year.
- Average Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2020 – 21. Certificate issued by Chartered Accountant must have 15 digit UDIN (Unique Document Identification Number) if issued on or after 01.04.2018.
- Net Worth of last Financial Year 2020-21 duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
- Solvency Certificate for the current financial year equivalent to an amount not less than 25% of the estimate cost of work. It should be drawn on schedule/nationalized Bank.
- Shop Act License

- Certificate of Registration for GST.
- PAN Card of the firm / proprietor as the case may be.
- List of T&P available with the agency for execution of the work.
- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
- 5. Rfx fee is Rs.105/- including taxes (Is non refundable).
- 6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 7. Income Tax will be deducted from contractor's bill, as per Govt. rules.
- 8. **Warranty**: 'The Contractor' will have to give a warranty / guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site / work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year the bidder shall give warranty of at least one year from the supply of material.
- 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
 - **Scope of work:** Repair, Testing and Refilling work of various Fire Extinguisher Cylinder under HVDC RS (O&M) Circle, Padghe.
 - 1) All the Refill Viz. CO2 gas Cartridges, DCP Powder, Mechanical Foam concentrate etc shall be as per relevant IS/UL or equivalent codes and marked. The refills used shall be of the same fire rating as that of Original Fire Extinguishers.
 - 2) Before Installation every Fire Extinguishers should be inspected for its completeness.
 - 3) Training/Demo should be arranged for creating awareness of Fire fighting Equipments.
