- 1. Sealed Quotation should contain following documents certificates as a proof of qualifying pre-requisites,

- b) Valid registration under GST.
- c)Copy of Pan card.
- d)Income Tax returns for last three financial year.
- e)Experience of similar work in MSETCL/or any organization. This should accompanied by experience certificate/purchase order.

- 2.Quotations with incomplete details or not submitted in due date etc. are liable to reject.
- 3. This office reserves all the rights to reject any or all quotations without assigning any reason thereof.
- 4.Rates quoted shall be inclusive of al taxes, Transportation , Loading , Unloading and other incidental charges. Nothing extra on any account will be paid.
- 5.Quantities mentioned in schedule A are approximate and may vary. However, the payment will be affected on the basis of actual quantity executed.
- 6.No material will be issued by the Company.
- 7. Contract period is 60 days from the date of issue of work order.
- 8.If any damage occurs to the Company's property during execution, contractors will have to make it good at his own cost.
- 9.If any accident occurs to contractor's personnel during the execution of work ,the company will not be responsible for the payment of any compensation to them. In such cases, it will be the contractors responsibility to pay the compensation as per the workmen Compensation act and the rules made under.
- 8. You have to remit, Security Deposit @ 5% of the total value of the orderin this office by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of order &

before execution of work. If you fail to do so, the SD will be recovered from your first bill with interest. The S.D. will be refunded after the completion of guaratee period.

9.If you fails to execute work within stipulated Time, penalty @ 1/2% per week, maximum to 10% of order amount shall be levied on contract value & GST applicable on LD amount.

10. You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereofto any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.

11.You should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same. Nothing else stated here all other general terms & conditions of MSETCL will be applicable to this work order.
