**Terms & Conditions:**

1. The rates should be quoted on firm quotation basis.
2. Your sealed quotation should reach this office on or before 21.02.2022 at 15:00Hrs & offer will be open on same day, if possible.
3. Quotation shall be sent under sealed cover duly subscribed as enquiry no.....& due Date....
4. **Name of Work:** work for repair of 33/22/11 KV outdoor CT's available at various sub-station under jurisdiction of EHV O&M Div-Baramati.
5. **Taxes & Duties:** The rates should be quoted be excluding taxes, levies, incidental charges, Octroi, packing, forwarding, transportation, statutory charges, etc if any freight, insurance.
6. **Rate Validity:** The rates offer submitted by you should be valid for at least 180 days from the last date of receipt of quotation.
7. **Security Deposit:** You will have to pay S.D. at rate 3% of the total amount or order within 7 days from the receipt of firm order, if asked for.
8. **Payment:** 100% payment will be made after the work completion by EHV O&M DN Baramati as per availability of Funds.
9. Along with quotations following documents should be attached,
  - A. Valid registration under GST.
  - B. Valid Shop Act License.
  - C. Valid Govt. Electrical Contractor license/ Supplier License.

D. Valid PAN registration

E. Bidder must be regular suppliers and have similar work experience executed from the authority not below the rank of Executive Engineer.

10. Agency Participating must have its own manufacturing/repairing facility/workshop along with factory testing facilities such as HV withstand test, Capacitance & Tan Delta test, Ratio & Knee point, Polarity test etc.
11. List of similar works executed by the contractor elsewhere preferably with testimony from the concerned shall be attached with the documents.
12. All general /technical /commercial terms & conditions of the contract of MSETCL are applicable to this contract.
13. **Quantity:** Quantities shown in Schedule “A” are tentative & subject to variation on either side.
14. The T&P labor, machinery, equipment /material required for the said supply of material shall be to your account.
15. **Penalty:** If you fail to supply the material in stipulated time as mentioned above, you will be liable to pay penalty at rate of ½ % per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.
16. **Guarantee:** The material to be supplied should be of the best & of standard quality & as per specification shown in schedule ‘A’. The defective material should be replaced at your risk & cost. The work carried out by You , will be guaranteed for 12 months from date of completion of work.
