3. Rates quoted should be on firm quotation basis and No extra charges for transportation, T&P, skilled workmen etc. will be arranged by you only.
4. Scope of Works:- Urgent work of providing spares and services for 400kV (ELF SP 6-21) ABB Make Circuit Breaker of 400KV Padghe-1 and 400KV Aurangabad Bay at 400kV R.S. Babhaleshwar under 400kV R.S.(O&M) Division/Babhaleshwar. The detail scope of work mentioned in Schedule 'A'.
5. Quoted Rates:- You are requested to quote your unit rates for the items mentioned in the schedule. (Please quote ex-works price in ex-works field &, applicable GST in GST field).
6. Payment: Payment will be effected after completion of work & as per actual work done.
7. Rates & Taxes: - The Rates quoted should be valid at least for 120 Days and should be including of all Labour charges & incidental charges including labour cess but excluding GST as per applicable rate & relevant act. Please quote your GST registration No. on quotation.
8. Work completion: - The entire work should be completed within 03 Months from the date of issuing the work order as per availability of outages. Work quality should be satisfactorily.
9. The income tax & other taxes will be deducted from your bill as per prevailing rules.
10. Comprehensive Insurance: You have to submit the comprehensive of United India Insurance Company Limited Policy of 60:40 ratio for work order amount as may be necessary to protect your (contractor) interests & the interest of The MSETCL, against all risk valid up to the work order completion period. It is responsibility of the contractor to takeout all necessary insurance of material/equipment/labour for execution of work for his liabilities direct/indirect and same must be attached with the invoice otherwise 1% on work order value will be deducted from bill.

scheduled Bank in the name of the Executive Engineer 400KV RS (O&M) Division Babhaleshwar to this office valid for one year. The same will be refunded only after satisfactory completion of guarantee period.

13. In any loss occurs to MSETCL's property during execution of work, the same will be recovered as per prevailing rates from your bill.
