Scaled and super scribed quotations are invited for the above work as per enclosed Schedule "A". Please quote your lowest rates in **two bid system** for AMC for Overhauling, troubleshooting & repair of 22/33 kV Circuit breakers in case of emergency breakdown & as and when required at various S/Stns under EHV O&M Division Pimpri Chinchwad, Pune as per Schedule 'A' attached herewith under the terms & conditions below.

Two bid systems should be followed for submitting the offer through registered post or in person to the Office of Executive Engineer, Pimpri-Chinchwad Division, Pune on or before **09.03.2022 upto 16:00Hrs**.

TERMS AND CONDITIONS:

A. Techno -Commercial bid:

- 1) The rate should be quoted on firm quotation basis. The rate should be inclusive of transportation of T&P, manpower to site. Taxes should be quote separately. If taxes not quoted separately rate will be considered as inclusive of taxes.
- **2)** Quotation shall be sent under sealed cover duly subscribed as QUOTATION FOR YOUR ENQUIRY NO ----- as above.

The offer should be submitted along with the following documents:

- 1. Copy of PAN Card
- 2. I.T return for the year AY 2019-20, AY 2020-21.
- 3. Proof regarding GST registration.
- 4. Valid shop act & establishment registration or NOC of Grampanchayat or Udyog Aadhaar certificate.
- 5. Valid Electrical contractor (registration) License
- 6. Details of work order / experience certificate issued by the competent authority not below the rank of Executive Engineer **for similar work** in MSETCL/MSEDCL/any other Govt. /PSU organization/OEM.

All general / technical/ commercial terms & conditions of the contract of the company are applicable to this contract.

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

B. Commercial bid:-

Bidder should quote the rate under commercial bid.

- 1. Techno-commercial bid will be opened against all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tender fulfills the desired prerequisites; the price bid (commercial bid) will be opened. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
- 2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
- 3. The technical documents should be submitted in the technical bid & commercial documents /offer/price bid should be submitted in separate envelopes, in case both technical & commercial bid are enclosed in one envelope wrongly, the offer will be rejected.
- 4. **WORK EXECUTION SCHEDULE:** In emergency/ Breakdown representative of agency should reach at site within 04 (four) hour from the time of intimation given by Executive Engineer or his representative i.e. concerned sub-station incharge. The work should be carried out immediately as per instruction of Executive Engineer or Engineer Incharge & failure to this penalty will be applicable.
- 5. **VALIDITY:** validity of the rates quoted by you should be four months from the date of quotation.
- 6. SUPPLY OF MATERIAL: It should be of standard make approved by MSTCL.
- 7. **PENALTY**: If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed hour in emergency work or per day as applicable, subject to a maximum limit of 10% of the total value of the order.
 - Loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will recover from the bill.
- 8. **QUALITY**: The work should be carried out as per satisfaction of Executive Engineer or Engineer Incharge & as per schedule 'A', otherwise same will be rejected and you will have to replace / repairs at your own risk and cost only.
- 9. **GUARANTEE**: The work as a whole shall be guaranteed for trouble free service for period of 12 months from the date of work carried out. If supply material found defective due to bad design or workmanship that should be replaced by you free of cost within 2 days or otherwise same will be deducted.
- 10. **GENERAL**: You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
- 11. <u>AGREEMENT</u>: You will have to execute the agreement bond with Executive Engineer, EHV O & M Division Pimpri Chinchwad, Pune on stamp paper of 500/-. The cost of stamp paper will be borne by you

- 12. <u>PAYMENT</u>: Payment will be made to you against after confirmation of work carried out from concerned sub-station incharge. Service entry / MIGO of the bills will be done by concerned sub-station incharge. Scrutinizing & auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.
- 13. **GST PAYMENT**: 100% GST payment will be done against invoice submission.
- 14. **SECURITY DEPOSIT:** You have to pay security deposit within 7 days from the date of receipt of the work order, amounting to 5% of the value of the contract in the form of FDR/D.D of any Nationalized/ scheduled Bank in the name of EE, EHV O&M Pimpri Chinchwad Division, Pune, payable at Pune valid for one year or by online payment NEFT/RTGS.
- 15. In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
- 16. **TERMINATION OF CONTRACT**:- The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 3 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor. Undue delay in completion of contract work is also liable to getting the work done through other agencies at the risk and cost of the contractor.
- 17. **JURISDICTION**: All dispute or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE court only.
- 18. **WORK CONTRACT TAX:** As per prevailing rates will be deduct from your bill, if applicable.
