Sealed & super scribed item rate quotations are invited so as to reach the office of **Addl. EE EHV CCCM S/Dn. Buldhana** on or before **17:00 Hrs. on 10.03.2022** for Hiring of Diesel taxi Vehicle as per Schedule 'B' enclosed & as per Terms & Conditions given below. Quotations will be opened in the office of **Executive Engineer (C), EHV CCCM Dn., Akola** on the next day at **12:00 Hrs.** if possible.

The contractor shall make the payment for cost of Quotation and EMD through Online mode RTGS/ NEFT in favour of **Executive Engineer (C), EHV CCCM Dn., Akola A/C. No. 04690200001813 (IFSC Code BARB0AKOLAX) Branch AKOLA.** Details of payment must be submitted with Quotation.

As Earnest Money deposit which will be refunded offline after placement of the order & deposition of security deposit, if after placement of order, taxi is not provided on hire basis then the amount of Rs. **3000/-** will stand forfeited. The amount will be refunded offline to those whose quotations are not considered for placing order.

The blank quotation form will be available at a **Cost of Rs. 105.00 (including GST) in the Office of Addl. Executive Engineer (C) EHV CCCM S/Dn. Buldhana** from **04/03/2022 to 10/03/2022** on working days from **11.00 Hrs to 17.00 Hrs. after verifying the vehicle's documents and Physical condition.**

The contractor should submit attested Xerox copies of all documents as given as per following terms & conditions at sr.no.6 along with the quotation. Right to split up the work or to reject any or all the quotations without assigning any reason thereof is reserved by the undersigned.

**Terms & Conditions:-**

1. All terms & conditions mentioned in the works & contract regarding to MSETCL are applicable.
2. The estimated cost of work is **Rs. 3,00,000/- only excluding of All Taxes & cost of diesel.**
3. The work contract shall have to be completed within a period of **12 Months** from the date of instructions to start contract ( **i.e. from dtd. 01.04.2022 to dtd. 31.03.2023 or limited to value of work order whichever is earlier.**)
4. Care shall be taken that the total expenditure per month including cost of vehicle days plus cost of diesel for individual month for the hired taxi vehicle should not be exceeded **Rs. 50,000/-per month (Rs. Fifty thousand per month only).**
5. No Lubricants will be supplied to the taxi owner.

6. The Contractor should submit attested Xerox copies of the following documents for official record.
  - a. Contractor should submit the self attested true copy of certificate of registration of Vehicle along with All India National Permit.
  - b. Attested Xerox Copy of R. C. Book / T. C. Book.
  - c. Valid Insurance Certificate
  - d. Valid Pollution Certificate
  - e. Partnership deed if it is a partnership firm.
  - f. PAN Card Xerox copy.
  - g. GST registration as per rules.  
(If registered )
  - h. Bank Details.
7. The contractor shall be responsible to abide all prevailing labour laws including Workmen's Compensation Act.
8. The contractor shall be responsible for any accident/damage caused during execution of work & he shall have to make good of the same at his own cost as directed. MSETCL will not be responsible for any fatal or non fatal accident to the person of the agency. The Agency will be responsible for any fatal or non fatal accident to the person of the agency.
9. The payment shall be made on R.A. Bills/Final bill.
10. You would have to make good all defects developed in the vehicle and also generally maintain the vehicle in good condition during the contract period.
11. The normal working hours will be in between 9.00 to 21.00 Hrs. or as directed by the **Addl. Executive Engineer (Civil), EHV CCCM Sub-Division, Buldhana.**
12. Responsibility of parking is of taxi owner .
13. In case of frequent failure / unsatisfactory services of the vehicle, the contract will be terminated by giving only 24 Hrs. Notice.
14. **The vehicle will be required on all working days in each calendar month or as and when required by competent Authority.**
15. The cost on account of maintenance / repairs, Drivers Wages/ allowances & vehicle taxes etc. if any shall have to be borne by the owner of the vehicle.
16. In case of failure/ Breakdown of vehicle, the arrangement of providing alternate vehicle is mandatory to owner. In case of permanent Breakdown/non-fitness of vehicle, new vehicle to be provided on recommendation of concerned SDO followed by necessary approval from Executive Engineer by verifying the vehicle's documents and Physical condition.
17. The R.T.O., Police Department liabilities & other legal liabilities on account of accident etc. will be at the cost & account of owner of vehicle.
18. **Term of payment:** - Payment will be made by A/C payee cheque on monthly basis as per rule by this office, after submission of printed bill form in triplicate by the agency through concern division office / sub-division office to this office.
19. No overtime will be paid for excess working hours, if utilized for any day and no halting charges will be paid.
20. **Jurisdiction:** - Any dispute or difference arising out of or any in connection with this Tender/ Quotation or contract as since concluded shall be subject to exclusive jurisdiction of the Akola Court only.
21. **Deduction :** The Company shall be entitled to deduct / recover the amount of liquidity/ the amount incurred on account of minor repair/Tyre puncture etc on road; from the current bill payable to you or from any other amount due for payable to you, against any other contract.
22. The Toll Tax will be paid by the department.
23. **SECURITY DEPOSIT:-**The successful Contractor / Contractors shall have to pay Security Deposit amounting to **Rs. 15,000/- (Rs. Fifteen Thousand only)** i.e. @ 5% (five percent) of the value of contract by cash / FDR within **07 days** of receipt of the letter of Intent/work order in the office of the **Executive Engineer (C), EHV Civil Construction cum Maintenance Division, M.S.E.T.C.L., Akola.** The successful Contractor shall also execute a stamped agreement bond of Rs. 500.00 at his own cost with the Executive Engineer (C), EHV Civil Construction Cum Maintenance Division, M.S.E.T.C.L., Akola, in the

- MSETCL's standard form within a fortnight from the issue of work order. No interest will be payable by the M.S.E.T.C.L. to the contractor on the Security Deposit in whatever form it is held by the M.S.E.T.C.L.
24. Driver should be matured enough and attend duties in clean & neat uniform.
  25. Driver should possess the valid license to run the vehicle.
  26. The quantities and estimated cost mentioned are approximate and liable for variation.
  27. GST will be applicable as per Government rule.
  28. It will be sole responsibility of the contractor to incur the liability of statutory obligation and to make the payments to the concerned Government Authority.
  29. Only the total quantity of the diesel work out as per the total run divided by the average will be provided by the company at company's cost. The excess diesel consumed over the average will be recovered from agency's bill amount. The fuel will be provided by department through imprest.
  30. The rate shall be quoted on per day basis along with mileage should not be less than 15 Km/Ltr. The order will be limited to 50,000/- per month inclusive of fuel.
