1. **Scope of work:** As per Schedule “A”.
2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR Hiring of Air conditioned vehicle i.e. Bolero or Scorpio or TUV or Ertiga or Equivalent vehicle along with driver for 400 kV Line Maintenance Sub Division Kumbhargaoon, Nanded Under 400 kV RS Division Kumbhargaoon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule “A” format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. \_\_\_\_ be quoted).
3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule “A”. Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
4. **Important Dates:** Quotations invited from **11.03.2021 from 10:00 Hrs**, so as to reach this office up to **17.03.2021 up to 17:00 hrs** and the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
5. **Taxes:** Taxes will be paid & recovered, as per rules.
6. **Period of Contract:** The period of vehicle will normally be 365 days from the date of engagement of vehicle or Upto the total expenses limited to order value, however if MSETCL Departmental vehicle allotment made by higher office, then the hired vehicle will be discontinued by giving 15 days' notice period.
7. **Order value:** Order value is limited to 2,99,307.0/- (In Words: Rs. Two Lakhs Ninety Nine Thousand Three Hundred and Seven only) inclusive of all taxes.
8. **Payment:-** The payment will be made on monthly ‘RA’ bill basis. Payment will be made after submission of that bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.

9. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, 400 kV R S Division Kumbhargaoon, Nanded from the date of issue of order.
