Sealed & super scribed quotations are invited for the work of Schedule “A” on following terms & conditions:-

1. **Scope of work:** As per Schedule “A” & condition no.10 & 18.
2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR P&F of 1.5 Ton Split Air conditioners at 400 kV R S Division Kumbhargaoon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule “A” format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. ____ be quoted).
3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule “A”. Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
4. **Important Dates:** Quotations invited from **15.03.2022**, so as to reach this office up to **21.03.2022 up to 17:00 hrs** and the same will be opened same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
5. **Taxes:** Taxes will be paid & recovered, as per rules.
6. **Documents required:** The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - A. Copy of Valid Shop Act.
 - B. Copy of Valid Proof of registration under GST.
 - C. Copy of Pan Card of the agency /owner of the agency.
 - D. Should be Manufacturer/Distributor/Dealer of the company mentioned in condition no.18.
7. **Quantity :-** Quantity shown in “Schedule” may vary as per requirement. However the order value will be limited to Rs. 99,198/- only (including all taxes/duties).

8. **Delivery Period :-** The material shall be supplied within 04 days from the date of receipt of this office order otherwise penalty @ 1% per week subject to maximum 10% of the order amount will be levied at the discretion of the Competent Authority.
9. The rates offer submitted by you should be valid for at least 90 days from the last date of receipt of quotation.
10. **Scope of work:**
 - i. Supply of 1.5T Split Air conditioner with all accessories.
 - ii. Fixing of supplied Air conditioner (if required to fix on Stand, the stand also to be provided by agency).
 - iii. Confirmation of cooling on final installation supplied Air conditioners.
11. The time being essence of the contract, the supplier should strictly adhere to the delivery period as per schedule 'A'. The delivery will be deemed to have been completed on the date of receipt of material at 400 kV R S Kumbhargaoon, Nanded.
12. **Sample:-** You will have to take approval of 1.5 Ton Split Air conditioners & dispatch to be done only after approval from Executive Engineer 400 kV R S Division Kumbhargaoon Nanded or his representative not below rank of Addl. EE.
13. **Payment:-** 100% payment will be made in reasonable time after actual P&F of 1.5 Ton Split Air conditioners and on receipt of bills in triplicate (Indicating PAN No., GST Reg. No.) to this office subject to availability of funds. No advance / part payment will be made. GST will be paid only when GST no. is quoted on the bill.
14. **Paying Office:-** The payment against this contract will be effected by Executive Engineer, 400 kV R S Division Kumbhargaoon, Nanded within reasonable time as per funds availability.
15. **Insurance: -** In all cases the insurance shall be affected by you with Government Insurance Fund for the total value of the order plus 10% to cover freight, GST and other incidental charges.
16. Please quote your **PAN & GST No.** in the quotation & provide **HSN code** for material to be supplied.
17. **Material:-** Material Received at 400 kV R S Kumbhargaoon, Nanded should be in good condition, party should have to transport all the material at their own risk & cost.
18. **Air conditioner Brand:** The Air conditioner provided by you must be of Bluestar/Samsung/Carrier/LG/Daikin/O General/Voltas/Whirlpool make only.
19. **Guarantee / Warantee for Quality of Material :** There must be Guarantee for satisfactory performance of the 1.5 Ton Split Air conditioners for period of 12 months from the date of receipt of 1.5 Ton Split Air conditioners at the desired location. The guarantee certificate should be submitted with the bill.

20. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD/ cheque / Bank guarantee to the office of the Executive Engineer, at 400 kV R S Division Kumbhargaoon, Nanded from the date of issue of order. The same will be refunded after completion of guarantee period.
21. The undersigned reserves the right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.
22. The undersigned reserves all the rights to cancel this E-Enquiry.
